# Sediment Management Standards, Chapter 173-204 WAC

The Department of Ecology proposes to adopt amendments to Chapter 173-204 WAC, Sediment Management Standards (SMS). The rule proposal will be published in the Washington State Register on September 5, 2012.

The purpose of this rule proposal is to amend Chapter 173-204 WAC. These amendments are needed in order to speed up the cleanup of contaminated sediment by providing clear, workable, and predictable requirements for sediment cleanup.

#### This rule-making:

- Integrates requirements for sediment cleanup actions in the Sediment Management Standards rule with requirements in the Model Toxics Control Act Cleanup Regulation (WAC 173-340).
- Updates the SMS cleanup decision framework to address bioaccumulative chemicals.
- Proposes chemical and biological benthic criteria for freshwater sediments.
- Clarifies requirements for coordinating cleanup actions and source control measures.

#### Ecology issued a:

- Determination of Significance and Environmental Impact Statement under the State Environmental Policy Act.
- Small Business Economic Impact Statement (SBEIS).
- Preliminary Cost-Benefit and Least Burdensome Alternative Analyses.

#### **WHY IT MATTERS**

The SMS rule is used to conduct environmental cleanup work, manage the dredging of sediment for navigation and cleanup and manages sources of contamination to sediment from dischargers.

Clarifying requirements to cleanup sediment contaminated with bioaccumulative chemicals will help make the cleanup process more effective, efficient, and protective of human health and the environment.

Cleaning up contaminated sediment is an important step towards restoring and protecting the state's waterways and valuable natural resources, such as fish and shellfish.
