

What's Happening Now at the NE Corner of Gas Works Park?

As part of Operations and Maintenance of remedial actions at Gas Works Park, Washington State Department of Ecology (Ecology) is performing work in the Northeast Corner of Gas Works Park.

The work involves capping and grading approximately 0.5 acres in the NE Corner of Gas Works Park. A geofabric demarcation layer will be placed over the grading area and one-foot of clean fill will be placed over the area. Following grading and maintenance activities, the Contractor will restore monitoring wells, storm drains and irrigation systems to accommodate the new surface grades and hydro-seed the area. In addition, 2 apple trees in the area will be removed. The project includes restoring the site.

*** PARK ADVISORY ***

Seattle Parks and Recreation will close the NE Corner of Gas Works Park for about four months while site grading and restoration work is completed. The NE Corner of the park will remain closed until grass has been restored in spring 2013.

Construction Schedule and Hours

Contractors for Washington State Department of Ecology will begin work on November 12, 2012 and continue through approximately December 31, 2012. Noise will be monitored, and City of Seattle's noise ordinance levels will not be exceeded. The work hours will take place during weekdays from 7 a.m. to 6 p.m.

Adverse weather conditions may delay the completion date. The area will be fenced and closed to the public until grass is restored in the area. See attached figure on page 2.

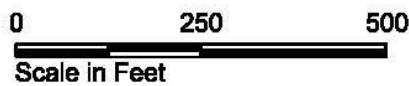
