Proposed Washington State Implementation Plan Update

In April 2014, the Department of Ecology (Ecology) will submit an infrastructure State Implementation Plan (SIP) for lead to the federal Environmental Protection (EPA). No new rules or requirements are being proposed.

The public can request a hearing. If a hearing is requested by 5 p.m. March 17, 2014, Ecology will hold one. If no request is received by the deadline, Ecology will not hold a hearing.

What is an infrastructure SIP?

An infrastructure SIP demonstrates that Washington has the means and authority to implement the federal air quality lead standard in all areas of the state. EPA updated the air quality lead standard in 2008. Ecology must submit the infrastructure SIP to fulfill the federal Clean Air Act requirement for this updated standard.

The major sources of lead emissions have historically been from fuels in vehicles and industrial sources. Lead levels in the air decreased dramatically since EPA worked to remove lead from gasoline in the 1970s. The major sources of lead emissions to the air today are industries that process ore and metals, and piston-engine aircraft operating on leaded aviation gasoline.

What is the new lead standard?

On October 15, 2008 the EPA strengthened the federal air quality standard for lead by lowering it from 1.5 micrograms per cubic meter ($\mu g/m^3$) to 0.15 $\mu g/m^3$ (based on a rolling three-month average).

Does Washington meet the standard?

Yes. Washington does not have any areas that violate the 2008 lead standard.

We don't currently have many lead sources in Washington. Battery recyclers, wood products facilities, pulp and paper mills, glass manufacturers, and refineries are a few of the sources that emit lead at very low levels in Washington.

Washington monitors for lead at the Beacon Hill site in Seattle. The data from this site show values well below the standard. Monitoring was also required at two airports for a 12 month period: Harvey Field in Snohomish and Auburn Municipal Airport. Lead levels were well below the standard at the two airports, so monitoring was discontinued.

Why are we revising the SIP?

Washington is required to submit an infrastructure SIP to EPA within 3 years following the issue of a new or revised air quality standard. The proposed infrastructure SIP certifies Washington has the authority, rules, and programs to continue to meet the 2008 lead standard.
