# Interim Action Plan and SEPA Determination of Non-Significance Available for Review and Comment

The Washington State Department of Ecology (Ecology) is providing an opportunity for the public to comment on its plans to conduct an interim action to address petroleum contaminated soils (PCS). An interim action is a partial cleanup designed to significantly reduce contaminants and/or exposure to contaminants. Ecology is also issuing a State Environmental Policy Act (SEPA) Determination of Non-Significance (DNS) at the former Frenchies Fill N Food Site (Site) located at 106 E Moxee Avenue in Moxee, Washington.

# Site Background

The Site has known petroleum contaminated soil (PCS), and potentially contaminated groundwater. This is due to a petroleum release from underground storage tanks (USTs), used for the former service station at the Site. USTs containing gasoline and associated fuel dispenser lines were removed in 1994. Groundwater was encountered at about 10 feet below ground surface during UST removal and subsequent investigation activities.

# **Proposed Interim Action**

The cleanup will include removal of the source area of PCS and replacing it with clean backfill. Ecology expects that some contaminated soils may need to be left in place in order to

protect the building structure and a municipal water supply main. A treatment system for any remaining soil contamination will be installed. Groundwater treatment with an oxygen releasing compound may be used to help stimulate microorganisms to assist in breaking-down petroleum into non-toxic products. Groundwater will be monitored to measure the effectiveness of this cleanup.

# **Determination of Non-Significance**

After reviewing the SEPA environmental checklist, Ecology has determined that the cleanup action will not have a probable significant adverse impact on the environment and an Environmental Impact Statement (EIS) is not required.

# Why This Cleanup Matters

Petroleum contains many chemicals that are harmful to human health and the environment, including benzene, a known carcinogen, as well as toluene, ethylbenzene, and xylenes.
