Agreed Order Amendment Available for Public Review and Comment

The Washington Department of Ecology (Ecology) invites comments on an amendment to an Agreed Order (legal agreement) for cleanup actions at the Fox Avenue Building LLC (Fox Avenue Building) Site in south Seattle. Last spring, Ecology finalized an Agreed Order to begin cleanup work at the site. Because of a recent EPA rule change, Ecology has revised some of the cleanup levels that were set for the site.

Why is the Agreement Being Revised?

- The Environmental Protection Agency (EPA) recently updated information about the toxicity of trichloroethylene (TCE), perchloroethylene (PCE), and Vinyl Chloride (VC). These are three of the indoor air contaminants at the Fox Avenue site.
- Because the state uses EPA information to calculate cleanup levels, the state cleanup standards for PCE, TCE and VC in indoor air were adjusted. The indoor air cleanup levels for the Fox Ave Building site are now higher.
- Changes to the indoor air cleanup levels include:
 - The PCE air cleanup level increased from 0.42 microgram per cubic meter ($\mu g/m^3$) to new level of 9.6 $\mu g/m^3$.
 - The TCE air cleanup level increase from 0.10 μ g/m³to the new level of 0.37 μ g/m³.
- Detailed cleanup levels are included in the amended Agreed Order and Cleanup Action Plan.

How Will This Affect the Cleanup Work?

- Thermal treatment and soil vapor extraction system will continue. These treatment systems have been in place since summer 2012.
- Indoor air will be tested at the Cascade Columbia and the nearby Seattle Boiler Works Buildings to make sure that the new standards are met.

You are invited to review the Agreed Order amendment and send your comments to Ecology for consideration. Comments will be accepted March 25 - April 26, 2013.
