

### Dangerous Waste Regulations (Chapter 173-303 Washington Administrative Code)

The Department of Ecology proposes to adopt amendments to the Dangerous Waste Regulations. The rule proposal will be published in the Washington State Register on September 3, 2014.

One purpose of this rule proposal is to update the dangerous waste regulations to be current with the federal hazardous waste program. Amendments will be made to incorporate several federal hazardous waste regulations, including a new rule simplifying waste management at university and college laboratories, changes to import/export rules, incorporating corrections to the United States Environmental Protection Agency (EPA) hazardous waste regulations, and a few other new, minor federal rules.

We are also proposing some state-initiated changes, including many technical and editorial corrections and clarifications. Other significant changes include:

- Establishing a thirty-day time limit for special wastes held at solid waste transfer stations.
- Clarify that an independent professional engineer must be used for regulatory certifications.
- Changes to existing financial assurance rules and proposing new rules for financial assurance at corrective action sites.
- Adopting a federal rule that allows use of enforceable documents in place of a post closure permit.
- Deleting a public disclosure rule that conflicts with state statute.

Ecology is also proposing changes to the Chemical Test Methods Guidance for designation of halogenated organic compounds.
