The Department of Ecology (Ecology) invites you to comment on the proposed renewal of the Specialty Minerals, Longview State Waste Discharge wastewater permit.

If we determine there is significant interest during this comment period to hold a hearing, we will:

- Extend the comment period to allow at least 30 days notice of the hearing.
- Publish the date, time and location.

### **Permit**

This permit allows Specialty Minerals to discharge:

- Wastewater and stormwater to the Weyerhaeuser, Longview wastewater treatment plant. Once treated by Weyerhaeuser, the wastewater is discharged to the Columbia River through Outfalls 001 and 002.
- Sanitary wastewater to the Weyerhaeuser Longview sanitary wastewater treatment plant.

The facility's permit was last issued October 2009. Changes to the permit include:

- Added monitoring for priority pollutants.
- Updated submittal requirement for the facility's Operations and Maintenance Manual.

Permit limits are unchanged. More information on changes to the permit is found in the associated fact sheet.

A State Waste Discharge permit is normally issued every five years. It:

- Sets limits on the kinds, amounts and concentrations of pollutants a facility may release.
- Requires a facility to measure, test and report its pollutants.
- Prescribes "best management practices."
- Sets other legal conditions necessary to discharge wastewater.

### Effective comments:

- Tell us how well, based on current laws, rules and regulations, the proposed permit protects receiving water.
- Provide input on limits, conditions and requirements.
- Let us know if you think we made errors interpreting state and federal permitting requirements.
- Are specific. Tell us specifically what your concern is and how you think the permit should change.

When the comment period ends, Ecology will review and consider all comments received and make appropriate changes to the permit before issuing it.

### **Facility information**

Located at 3515 Industrial Way in Longview, Specialty Minerals produces precipitated calcium carbonate by reacting carbon dioxide with slaked lime.
