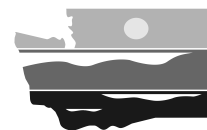

Site Proposed for Removal from the Hazardous Sites List

Ecology invites you to comment on a proposal to remove the Washtucna Fertilizer Plant site from the Hazardous Sites List.

The site was used for several retail and wholesale operations in the agricultural community from the early 1950s until 2000. Uses included bulk fuel storage and sales, retail supply, hardware supply, vehicle maintenance, bulk feed, and storage of agricultural chemicals.

Ecology took several steps to clean up soil contamination at the site. In 2014 nearly 117 cubic yards of petroleum impacted soils were removed and disposed of off-site. Above-ground tanks used to store petroleum were also removed.

Cleanup standards for soil have been met over an extended period of sampling since 1994.

As a result of the cleanup work conducted, a “No Further Action” determination was issued. The site now qualifies for removal from Ecology’s Hazardous Sites List.

Agreed Order Available for Public Review and Comment

Ecology invites the public to comment on a new agreed order (legal agreement) for the Pacific Wood Treating site. The agreed order requires the Port of Ridgefield to:

- Develop a sampling plan for investigating dioxins in a neighborhood adjacent to the Lake River Industrial Site.
- Do a remedial investigation (RI), which describes the type and extent of contamination.
- Do a feasibility study (FS), which evaluates cleanup options.
- Develop an RI/FS report.
- If Ecology decides one is needed, develop a preliminary draft cleanup action plan, which proposes cleanup actions.

Most of the dioxins in off-property soil likely came from air-borne dust while PWT was operating. Dust may have blown off the port property, been tracked onto roads from truck tires, and come off trucks hauling treated wood on Division Street.

Prospective Purchaser Consent Decree Available for Public Review and Comment

Ecology and Skagit County will enter into an agreement called a prospective purchaser consent decree for cleanup at the Truck City Truck Stop site. The 10-acre parcel located at 3216 Old Highway 99 South in Mount Vernon. The county plans to use the site for a new Skagit County Jail.

The proposed county jail is designated as an Essential Public Facility by the city of Mount Vernon. The site currently contains six buildings associated with the commercial operations of the gas station, truck stop and truck wash, restaurant, and retail store.

Under the proposed prospective purchaser consent decree, Skagit County agrees to complete the following site actions:

- Finalize a remedial investigation and feasibility study report that presents the results of the site investigation and evaluates cleanup alternatives.
- Prepare a draft cleanup action plan.
- Finalize the drafted cleanup action plan after the public comment period.
- Implement the cleanup action plan.

Ecology is the lead agency for the State Environmental Policy Act (SEPA) for the draft cleanup action plan and SEPA checklist and Determination of Non-Significance (DNS). Ecology determined that the proposed actions do not have a significant adverse impact on the environment and issued a DNS.

Ecology has prepared a public participation plan for the site. The plan describes the tools and approaches used to inform the public, request comments, and engage in them in the cleanup process

Negotiations Extended for Draft Cleanup Action Plan and Consent Decree

Ecology plans to begin negotiations on October 16, 2014, with Holcim (US) Inc. and the City of Spokane Valley for a draft cleanup action plan and consent decree. Negotiations originally were set for 60 days, but have now been extended until Jan. 16, 2015.

The draft cleanup action plan evaluates cleanup options for the site and identifies Ecology's preferred cleanup actions. The consent decree is the legal agreement between Ecology, Holcim (US) Inc. and the City of Spokane Valley that implements the draft cleanup action plan.

Both of these documents are draft until Ecology reviews, considers and potentially amends the documents, if appropriate, based on public comment received during the comment period.

The site was previously used for cement manufacturing operations. Cleanup work focuses on the cement kiln dust (CKD) contamination which is a by-product of the cement manufacturing. The cleanup work is necessary because cement kiln dust (CKD) remains in two locations on the property. CKD is found on the Holcim property on the north plateau portion of the land. A smaller deposit is located north of the fence on property owned by the city.

CKD generally may contain arsenic, cadmium, and lead, and can have a high pH. The property is close to the Spokane River and aquifer. Past studies found arsenic in groundwater at levels that exceeded state standards.

Periodic Review Available for Public Review and Comment

Ecology invites you to review and comment on a document called a periodic review for the Becker Buick Sprague Ave site. A periodic review is conducted at least every five years after the initiation of a cleanup action at a site, as required by the Model Toxics Control Act (MTCA).

The purposes of the review are to evaluate site conditions after cleanup is considered complete, and to ensure protection of human health and the environment.

The Becker Buick site is located at 636 East Sprague in Spokane. The site has been used as an automobile sales and service facility since 1953. Cleanup actions began at the site in December 1991 when an underground storage tank containing waste oil was removed. Associated piping also was removed. The tank had been taken out of service in 1989 and a new tank installed to hold waste oil. Investigations led to removal of 8 tons of soil.

Additional investigations and cleanup continued in 2002 because of petroleum hydrocarbons in soil. Two underground storage tanks containing gasoline and the hydraulic automotive hoists inside the service building and associated piping were removed. Another 10 tons of soil were removed from the excavations. Some contaminated soil remains at the site because it is under structures that could be damaged by trying to remove the soil. The groundwater at the site is not impacted by the contaminated soil. An environmental covenant was placed on the property to limit how the site may be used and protect the cleanup actions that have been taken at the site.

Ecology conducted a site visit June 4, 2014. The building that remains at the site and the concrete cover over contaminated soils eliminates potential direct exposure to contaminated soils. The concrete surface appears in excellent condition and no repair, maintenance or contingency actions have been required. The site continues to be occupied by the Becker Buick Automotive Dealership and provides automotive sales and service.

Ecology has determined the following based on the periodic review:

- The cleanup actions completed at the site appear to be protective of human health and the environment.
- Soil cleanup levels have not been met at the site; however, under WAC 173-340-740(6) (f), the cleanup action is determined to comply with cleanup standards, since the long-term integrity of the containment system is ensured and the requirements for containment technologies have been met.
- The covenant for the property is in place and will be effective in protecting public health and the environment from exposure to hazardous substances and protecting the integrity of the cleanup action.

Ecology will review all comments received during the comment period and modifications to the periodic review will be made based on public comment, if appropriate. If no significant changes are made, the review will be finalized. If significant changes are made, an additional public comment period will be held.

Responsive Summary Available for Public Review

Ecology has responded to comments it received on environmental cleanup documents for the Cornwall Avenue Landfill cleanup site. The comments and responses are included in a document called "Response to Comments," which can be viewed at Ecology's Cornwall webpage by following the link below.

Ecology held a public comment period from June 2 through July 2, 2014, to take comments on a consent decree and cleanup action plan, a public participation plan, and a Determination of Non-Significance under the State Environmental Policy Act. Ecology also held a public meeting to present the cleanup plan for the site on June 5, 2014, and again on July 5, 2014, for Spanish-speaking people. Both meetings were held in Bellingham at the public library.

Ecology received comments from eight individuals and organizations. Although the comments did not change the selection of the cleanup alternative, Ecology added some minor clarifying language to the cleanup action plan based on the comments. The cleanup action plan and the other documents are now considered final.

The consent decree, including the cleanup action plan, addresses two areas of the site – an upland portion and a shoreline/shallow off-shore portion. A third off-shore, deeper-water portion of the site will be addressed under a future amendment to the consent decree and cleanup action plan.

The consent decree and cleanup action plan will be recorded in Whatcom County Superior Court, and the cleanup will now move forward into design and permitting.

A public comment period was held from July 14 to August 27, 2014, to take comments on a feasibility study report, consent decree and cleanup action plan, public participation plan, and Determination of Non-Significance under the State Environmental Policy Act. Ecology received comments from nine individuals and organizations.

Based on the comments received, minor revisions were made to the feasibility study report and cleanup action plan. The revisions are identified in the "Response to Comments". Because the revisions were not substantial and did not result in any change to the selection of the cleanup alternative, these documents are now considered final.

The consent decree and cleanup action plan will be recorded in Whatcom County Superior Court, and the project will then move forward into design and permitting. Construction is expected to begin in 2016.

Engineering Report Available for Public Review

An engineering design report for the Laurel Station site has been produced and is available for viewing. The report covers:

- Remedial measures including affected soil removal and a dual-phase extraction system to treat soil and groundwater.
- Cleanup levels and points of compliance.

The contamination – petroleum crude oil and associated chemical fractions – is the result of older spills at a pipeline pumping station that have affected soil and shallow groundwater.

Most of the remaining contamination is restricted to an area beneath, and adjacent to, the pump station building and connected infrastructure. The majority of the remedial action is focused there.

Notification of Cleanup Action Plan Implementation

In accordance with (1) the July 2014 remedial investigation /feasibility study report and cleanup action plan (CAP) for this site, and (2) Ecology's associated September 30, 2014, Voluntary Cleanup Program opinion letter, the following is a summary of CAP implementation activities at the former 1,2&0 Cleaners site at 513 S. Meridian St. in Puyallup and prior dry cleaner operations at the same address. The release being remedied is a release of the dry cleaning solvent tetrachloroethene (PCE):

The expected cleanup actions are:

- Recording an environmental covenant with Pierce County to prevent unplanned and unmitigated removal of impacted site soil, to prevent installation of a future drinking water well within the Site boundary, and to require long-term groundwater monitoring (GWM) and operation of an existing sub-slab depressurization (SSD) system.
- Conducting periodic land use inspections to help ensure the environmental covenant is performing as intended.
- Conducting long-term GWM activities to confirm that constituents in on-site groundwater do not migrate off-property.

- Operating the existing SSD system.

The environmental covenant is expected to be recorded with Pierce County by December 31, 2014. Land-use inspections and GWM events are scheduled to occur on an approximately 18-month frequency, with the next land-use inspection and GWM event scheduled for March 2016. Operation of the existing SSD system is ongoing.

GLOSSARY

Agreed order - A legal agreement with Ecology to make sure the cleanup meets the standards of Washington State's cleanup law, the Model Toxics Control Act (MTCA).

Cleanup action plan (CAP) - A document that describes the selected cleanup method(s) and specifies cleanup standards and other requirements. It is based on information and technical analyses generated during the RI/FS and consideration of public comments and community concerns. A draft of the CAP (DCAP) is made available for public review and comment before finalizing.

Comment period - A time period during which the public can review and comment on various documents and Ecology or EPA actions. For example, a comment period is provided to allow community members to review and comment on proposed cleanup action alternatives and proposed plans. Also, a comment period is held to allow community members to review and comment on draft feasibility studies.

Consent decree - A formal legal agreement that is filed with a court. It describes studies and/or cleanup work to be done at a site and the terms under which that work is to be done.

Engineering design report - Engineering design reports outline the specific details for implementation and operation of the first phase of the cleanup actions.

ERTS - Environmental Report Tracking System

Five-year periodic review - A periodic review is conducted at least every five years after the initiation of a cleanup action at a site, as required by the Model Toxics Control Act (MTCA). The purposes of the review are to evaluate site conditions, after cleanup is considered complete, and to ensure protection of human health and the environment.

Hazardous Sites List - A statewide list of contaminated properties. Ecology may remove a site from the list only after determining that all remedial actions except confirmational monitoring have been completed and compliance with the cleanup standards has been

achieved at the site, or the listing was erroneous.

Independent cleanup action - Any remedial action without department oversight or approval and not under an order or decree.

LUST - Leaking Underground Storage Tank

NFA - No Further Action

Public participation plan - Outlines and describes the tools Ecology will use to inform the public about site activities, and it identifies opportunities for the community to become involved in this process.

PSI - Puget Sound Initiative

RCW - Revised Code of Washington

Remedial action - Construction work done to clean up a contaminated site.

Remedial investigation/feasibility study - Two distinct but related studies. They are usually performed at the same time, and together referred to as the "RI/FS."

Responsiveness summary - A summary of oral and/or written public comments received by Ecology during a comment period on key documents, and Ecology's responses to those comments.

RI/FS - See Remedial Investigation/Feasibility Study

SEPA - State Environmental Policy Act

Site Hazard Assessment (SHA) - An assessment to gather information about a site to confirm whether a release of hazardous substances has occurred and to enable Ecology to evaluate the relative potential hazard posed by the release.

UST - Underground Storage Tank

UXO - Unexploded Ordnance

Voluntary Cleanup Program (VCP) - The VCP is one of several options for cleaning up a hazardous waste site under the state's cleanup law. Under this option, property owners may perform a cleanup independently and request services from Ecology for a fee.

WAC - Washington Administrative Code

WARM, Washington Ranking Method - The method used to rank sites placed on the Hazardous Sites List.
