

Proposed Removal from the Hazardous Sites List

The Department of Ecology (Ecology) proposes taking the Trident Metals site off the Hazardous Sites List. It is located at 1851 Taylor Way in Tacoma. You may comment on this decision from **June 26 - July 28, 2014**. The box to the right shows where to find:

- A No Further Action letter that describes and approves the cleanup.
- Background documents about the site.

Site Background and Cleanup

From 1913 - 2003, the property housed a door factory. Trident Metals then used it for metals recycling until they closed in 2011. The property is now vacant.

In 2011, the site was ranked on the Hazardous Sites List because of oily runoff from the site to the Hylebos Waterway and poor hazardous materials management. Trident Metals used an old concrete slab to store metals. During investigations before redevelopment, a new owner found petroleum contamination under the slab.

In 2012, the new owner removed 318 cubic yards of petroleum-contaminated soil from under the slab. Follow-up sampling did not find petroleum contamination above state cleanup levels in soil or groundwater. Ecology considers the cleanup complete.

What Happens Next

1. Through July 28, Ecology invites you to comment on our decision to remove the site from the Hazardous Sites List.
2. After the comment period, we will respond to comments.
3. Ecology may require further sampling or cleanup based on information given by the public. Otherwise, Ecology will remove the site from the Hazardous Sites List.



What is the Hazardous Sites List?

The Hazardous Sites List includes sites that Ecology has assessed for their potential risk to human health and the environment. Sites must go through cleanup and meet state standards before Ecology can remove them from the list.


