

Proposed Removal from the Hazardous Sites List

The Washington State Department of Ecology (Ecology) proposes removing the Eddon Boat Park site from the Hazardous Sites List. You may comment on this from **January 9 — February 10, 2014**. The box to the right shows where to find the following supporting materials:

- A **letter of satisfaction**, which states the City of Gig Harbor (the city) met all activities the agreed order (legal agreement) required.
- A **project completion report**.
- A **cleanup action plan** and **agreed order**, which describe how the city cleaned up the site.
- **Monitoring reports** for 2009—2013.

Background

The Eddon Boat Park site is located at 3711 and 3805 Harborview Drive in Gig Harbor. The site was a residence, boatyard, and boathouse from the 1940s until 2003. The city bought the property in 2005.

Decades of boat repair and maintenance polluted site land and water above state cleanup levels. Contaminants at the site included:

- Heavy metals
- Polycyclic aromatic hydrocarbons (PAHs)
- Polychlorinated biphenyls (PCBs)
- Tributyltin (TBT)

Cleanup

The city removed contaminated soils, sediments, and treated timber bulkheads from the site. It covered less contaminated sediments with sand and gravel. A restrictive covenant is in place to prevent the release of contaminants that are safely capped.

After the city completed the cleanup, it monitored the site for five years to ensure the cap remained in place. Ecology now regards cleanup of the site complete.

What Happens Next

At the end of the comment period, we will respond to comments in a responsiveness summary. We will send this document to those who commented and post it online. The last step is to remove the site from the Hazardous Sites List. We will also do a periodic review of the site at the end of 2015.

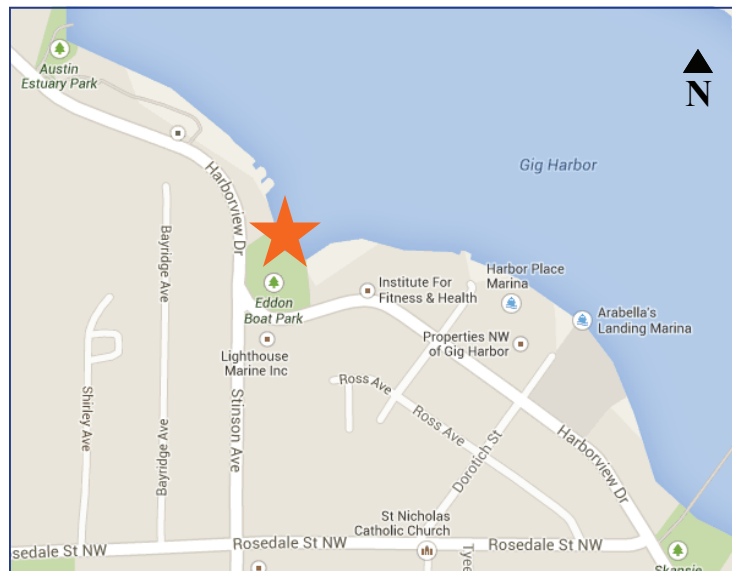
