NORPAC Refiner Project Comment Period

The Department of Ecology (Ecology) invites you to comment on proposed Notice of Construction Order No. 11272 and the associated State Environmental Policy Act (SEPA) Determination of Nonsignificance (DNS) for Weyerhaeuser, Longview.

We will accept comments by mail, fax, or e-mail May 15 – June 15, 2015.

Notice of Construction Order

The proposed order would approve the pulp refiner project at the North Pacific Paper Corporation (NORPAC) facility. This includes:

- Restarting two unused reject refiners for Thermomechanical Pulp (TMP) Mill No. 2. Currently, wood fibers not broken down enough for use in paper making are sent back to the secondary refiner. After the project, the two rebuilt reject refiners will break these fibers down, and they will not need to back go to the secondary refiner.
- Installing low consistency post refiners before Paper Machines 1 and 3.

The project would:

- Lower energy and pulp costs.
- Use energy more efficiently.
- Give the mill the ability to produce about 64,000 more bone dry metric tons (BDMT) of wood pulp each year.
- Increase some air pollutants. These include:
 - Volatile Organic Compounds by 13.1 tons per year (TPY).
 - Acetaldehyde by 10,596 pounds per year.
 - Formaldehyde by 453 pounds per year.
 - Methanol by 36,704 pounds per year.
 - Methyl ethyl ketone (MEK) by 7 pounds per year.

Facility Information

Weyerhaeuser and Nippon Paper Industries co-own the NORPAC facility located at 3401 Industrial Way in Longview. NORPAC produces newsprint and printing and specialty paper using TMP, deinked pulp from recycled newsprint, and bleached kraft pulp from Weyerhaeuser's Longview pulp mill.

In 2014, the facility produced:

- 565 bone dry metric tons (BDMT) of TMP.
- 57,000 BDMT of deinked pulp.
- 765,000 air dry metric tons of paper products.
