

Proposed Removal of Environmental Covenant

The Washington Department of Ecology (Ecology) invites you to comment on our proposal to remove a restrictive covenant (also called an environmental covenant) for the Alexander Farms Site located at 179101 West King Tull Road in Benton County, Washington.

What is a Restrictive Covenant?

A restrictive covenant (also called an environmental covenant) is a legal document. It prohibits activities that may result in the release of a hazardous substance that remains on a site after cleanup. A covenant is attached to the property deed and filed with the County Assessor.

Public Comment Invited

Ecology is asking for your comments on the proposed removal of the environmental covenant. You are invited to:

- **Review** the restrictive covenant, recorded in 2006, and the covenant removal request.
- Review the Consent Decree Notice of Completion letter, issued in 2009.
- **Send** your comments to Ecology for consideration. Comments will be accepted *April 2, 2015 through May 4, 2015*.

Site Background and Cleanup

In April 1998, Ecology responded to complaints of yellow water coming from two domestic wells in the vicinity of the Alexander Farms site. Ecology determined that the soil and groundwater at the site was contaminated with Dinoseb, a herbicide that was banned from use by the United States Environmental Protection Service (US EPA) in 1986.

Between 1998 and 2005, approximately 15,000 tons of Dinoseb contaminated soil was excavated from the site. The soil, which was acting as the source of ground water contamination, was hauled to a licensed disposal facility in Arlington, Oregon.

Between 2005 and 2008, 14 ground water monitoring wells were sampled quarterly (every 3 months) and analyzed until the ground water in all the wells remained below cleanup levels for Dinoseb for eight consecutive quarters (2 years). As of January 2008, the ground water from all 14 wells had tested below cleanup levels for two years.

Based upon review of the Cleanup Action Reports and 11 years of data, Ecology determined the site is no longer a threat to human health and the environment. Ecology removed the Site from the Hazardous Sites List in May 2009.

Proposed Covenant Removal

The property owner has requested permission to rescind the restrictive covenant for the Alexander Farms Site. The restrictive covenant explicitly states that it may be rescinded when groundwater concentrations of Dinoseb are below 7 micrograms per liter. This condition has been met at the Site. Ecology proposes to grant permission for the restrictive covenant to be rescinded for the Site.

What Happens Next?

After the public comment period ends, Ecology will review comments received during the comment period. If no changes are necessary, Ecology will grant permission to rescind the covenant from the Site.
