Ecology proposes to remove the US DEA OPNTF Lawrence Rd Port Angeles site from the Hazardous Sites List. In 2002, Clallam County officials demolished a methamphetamine laboratory on the property. Over time, petroleum-related chemicals broke down and dispersed naturally. No contamination remains above cleanup levels. The site was cleaned up under the Voluntary Cleanup Program.

State Environmental Policy Act and Determination of Non-Significance Available for Public Review and Comment

Ecology's Toxics Cleanup Program is currently overseeing cleanup of contamination at the Pasco Sanitary Landfill site. The landfill has a municipal waste and an industrial waste area. Drums of hazardous materials were disposed in the industrial waste area and they are leaking. The landfill is closed.

However, continued cleanup requires installation of special equipment called a regenerative thermal oxidizer (RTO). The RTO will treat emissions of gases that will be removed by the soil vapor extraction (SVE) system located in the industrial waste portion of the site.

The SVE system collects the contaminants from beneath the soil and then they are oxidized or burned by the RTO. Once the contaminants are partially or completely burned, by-products are emitted from the RTO.

An air quality permit is in process and the next step is to gather public comment about the State Environmental Policy Act (SEPA) checklist and Determination of Non-Significance (DNS) for the RTO. These documents are available for public comment June 25 through July 10, 2015.

Ecology will review all comments received during the comment period and make changes to the SEPA/DNS, if appropriate. If no significant changes are made, the review will be finalized. If significant changes are made, an additional public comment period will be held.

Periodic Review Available for Public Review and Comment

Ecology invites you to review and comment on a document called a periodic review for the PSC-Georgetown (aka Burlington Environmental-Georgetown) facility at 734 S. Lucile St. in Seattle. Burlington Environmental, LLC is a wholly-owned subsidiary of PSC Environmental Services LLC, which is a wholly-owned subsidiary of Stericycle Environmental Solutions Inc.

Ecology conducts periodic reviews at least every five years after the initiation of a cleanup action at a site. Periodic reviews are required by the Model Toxics Control Act (MTCA), which outlines how state environmental clean-ups proceed. During the review, Ecology evaluates site conditions and ensures continued protection of human health and the environment when institutional controls are used as part of a remedy. This is the first periodic review for the PSC-Georgetown site.

The PSC-Georgetown site includes areas of groundwater contamination on the facility immediately east and north of the property and extending west and southwest to areas west of 4th Avenue South. Some of the contamination approaches the Duwamish Waterway. The cleanup of contaminated areas in the eastern part of the site, east of 4th Avenue South, is governed by Agreed Order DE# 7347 and its attached cleanup action Plan (CAP). This periodic review only applies to this part of the site and those required cleanup actions established in the May 28, 2010, Agreed Order DE# 7347 and its attached CAP.

Hazardous substances in soils and groundwater at the site include volatile organic compounds, semi-volatile organic compounds, PCBs, and toxic inorganics (such as metals). The primary contaminants of concern in site groundwater today are trichloroethene (TCE), vinyl chloride (a breakdown product of TCE), 1,4-dioxane, and petroleum-related compounds that are limited to the far eastern portion of the site. The 2010 CAP sets out the final remedy for the eastern portion of the site. This includes:

- Excavation.
- Soil vapor extraction.
- Capping or covering areas of soil contamination.
- Continued reliance on the subsurface barrier wall installed in 2004.

Groundwater cleanup levels protective of surface water and indoor air will be met using monitored natural attenuation. The restoration timeframe is 22 years. Environmental covenants to limit use and activities at the site are required on the company's properties and an adjacent property to the east, owned by Union Pacific Railroad.

Based on Ecology's review and site inspection conducted on April 9, 2015, Ecology concludes that human health and the environment are currently protected at the site. A number of the 2010 CAP's cleanup actions have been successfully completed; however, several actions need to be carried out in the near future. These include:

- Finalizing Environmental Covenants on the PSC/Stericycle and Union Pacific Railroad Argo Yard properties.
- Implementing a new action to hasten attainment of 1,4-dioxane cleanup levels.
- Initiating the groundwater bioremediation action behind the subsurface barrier wall.

Ecology will review all comments received during the comment period and make changes to the periodic review, if appropriate. If Ecology doesn't make significant changes, the review will be finalized. If Ecology makes significant changes, Ecology will hold an additional public comment period.

Proposed Agreed Order Amendment Available for Public Review and Comment

Ecology welcomes your comments on a proposal to amend an agreed order (# DE 7347) issued to Burlington Environmental. Burlington Environmental LLC is a wholly-owned subsidiary of PSC Environmental Services LLC, which is a wholly-owned subsidiary of Stericycle Environmental Solutions Inc. The PSC-Georgetown facility is located at 734 S. Lucile St. in Seattle. The facility and site are referred to as PSC Georgetown.

The agreed order amendment has new requirements for a proposed cleanup action of 1,4-dioxane contamination in site groundwater. Ecology also welcomes comments on our State Environmental Policy Act (SEPA) threshold determination for the proposed cleanup action.

Site groundwater is contaminated with 1,4-dioxane, as well as other hazardous substances, both east and west of 4th Ave S. Ecology proposes using in situ chemical oxidation to lower 1,4-dioxane levels and meet cleanup standards faster. We also propose that in situ bioremediation follows the chemical oxidation action, if new studies at the site indicate this can be done effectively and safely. A draft amendment is ready for public review and comment.

Ecology will consider and respond to all comments the public submits. We will then make a final decision on the proposed cleanup action and Order amendment. We will inform everyone who commented about the decision. If there is enough public interest in our proposal, we will hold a public meeting before making our decision.

Documents Related to Prospective Purchaser Consent Decree Available for Public Review and Comment

Touchstone North Lake Union (North site), the North Yard portion of the former Metro Lake Union site, is located at 3301 Densmore Ave. N in Seattle. In 2007, Touchstone entered a legal agreement with Ecology called a prospective purchaser consent decree (PPCD) to define Touchstone's cleanup actions if it purchased the North site. The North site was purchased in 2009. It is the former Metro Lake Union North Yard, approximately one-half of the Metro Lake Union site, and the former Chevron Bulk Petroleum Terminal #100-1327 site at 1602 N Northlake Way, Seattle.

Touchstone has performed the cleanup actions for the North site as required by the PPCD. The petroleum contaminated soils were removed for off-site treatment and/or disposal at an approved facility. Post-excavation soil testing showed all known petroleum soils have been removed from the North site and that remaining soil meets cleanup levels for unrestricted land use.

The North site cleanup actions and post-excavation soil testing results are described in a remediation action report. This site has an environmental restriction limiting groundwater use at the property. Ecology proposes to approve the report and to issue a determination that the requirements of the PPCD have been satisfactorily completed. Ecology invites comments on the following:

• A remediation action report by Associated Earth Sciences Inc. (AESI) dated March 20, 2015.

• Ecology proposal to issue a written notification that the requirements of the PPCD have been satisfactorily completed and to dismiss the prospective purchaser consent decree No. 07-2-23870-1SEA with Cleanup Action Plan-Touchstone NLU LLC North site.

State Environmental Policy Act Checklist and Determination of Non-Significance Available for Public Review and Comment Ecology proposes to conduct a pilot test at the Airport Kwik Stop site at 2102 Highway 31 in Ione.

The pilot test will include a combined air sparge and soil vapor extraction system east of SR 31 and south of Dewitt Road, near the former Cabin Grille. This test will determine if a full-scale treatment system is needed for the site. One additional air sparge well will be installed, and a new metered electrical service will be installed. One or more new power poles will be installed for the electrical connections for the pilot system. Details are in the SEPA Checklist.

A State Environmental Policy Act (SEPA) was completed for the original project. This new SEPA addresses the work associated with the proposed pilot test. SEPA requires government agencies to consider potential environmental impacts of a project before beginning the cleanup. The Determination of Non-Significance (DNS) indicates there is no probable adverse impact from the project to the environment.

Ecology will review all comments received during the comment period and make changes to the SEPA DNS, if appropriate. If no significant changes are made, the review will be finalized. If significant changes are made, an additional public comment period will be held.

Ecology invites the public to comment on a consent decree amendment and draft periodic review report for the Bunce U Rent cleanup site. Ecology reviews cleanup sites every five years to make sure they still protect human health and the environment.

Underground storage tanks contaminated site soil and groundwater with petroleum. The tanks were removed in 1998 and the site was cleaned up. Some contamination remains on site. This soil is capped and an environmental covenant prohibits activities that could disturb it.

Based on the 2015 site visit, Ecology determined that the asphalt cap continues to eliminate direct exposure to contamination. No groundwater contamination was detected in the 2014 testing.

Periodic Review and Consent Decree Amendment Available for Public Review and Comment Ecology invites the public to comment on a consent decree amendment and draft periodic review report for the Hidden Valley Landfill cleanup site.

Pierce County and LRI cleaned up the site by closing the landfill, collecting and treating leachate (contaminated water), capping the site, and controlling landfill gas.

Ecology reviews cleanup sites every five years to make sure they still protect human health and the environment. Cleanup actions at this site appear to be protective. Ecology is revising the groundwater monitoring plan, which is a part of the consent decree, to include testing for 15 more metals and other parameters. Groundwater monitoring frequency will increase to four times a year, after which we will evaluate the schedule.

Ecology is proposing to remove the Ed's Transmission Exchange site at 10226 Highway 99, Marysville, from the state Hazardous Sites List.

The site is located within a property that has been utilized for an automotive repair and maintenance facility since 1969, and is currently used for that purpose. The facility came to Ecology's attention in 1992 through reported mismanagement of waste oil. Preliminary samples taken by the Snohomish Health Department in 1999 confirmed the preference of petroleum hydrocarbons and metals in soil above cleanup levels on the property.

More extensive sampling was accomplished by the property owner during 2012. Lead was consistently detected in the soil and established as the primary contaminant of concern. There were also some detections of petroleum hydrocarbons oil range and other metals. Groundwater was not impacted.

The cleanup action selected for the site was a remedial excavation. This cleanup action accurately determined the extent of the contamination in soil and was a permanent remedy. Cleanup at the site took place between June and October 2013. Approximately 181 tons of contaminated soil were excavated and taken to a permitted facility.

Confirmation samples demonstrated that the contaminants in the soil on the property were below state cleanup standards.

Ecology has determined the site meets state cleanup standards protective of human health and the environment. Therefore, this site now can be delisted from the Hazardous Sites List.

You are invited to review and comment on a document called a periodic review for the Manito Shopping Center site. A periodic review is conducted at least every five years after the initiation of a cleanup action at a site, as required by the Model toxics Control Act (MTCA). The purposes of the review are to evaluate site conditions after cleanup is considered complete, and to ensure continued protection of human health and the environment.

The site consists of two parcels. The majority of the site includes a shopping center parking lot and a small portion of the site extends under the commercial building. The businesses include the Manito Tap House, Ross Dress for Less, Republic Pi Pizza, US Bank, and Chase Bank located adjacent to the parking area on the north and east of the site. Washington Trust Bank is on adjacent property to the south.

Contaminants of concern in soil included, tetrachloroethene (PCE), trichloroethene (TCE), chloromethane, PAHs and cPAHs. Additional contaminants were detected but were below levels of concern according to state standards.

Groundwater monitoring for five consecutive quarters through April 2009 indicated there is no contaminated groundwater at the site.

Since limited amounts of cPAHs and solvents remain in soil at levels that do not meet state standards, a covenant was placed on the property to limit how it may be used. The restrictions also limits activities that might interfere with the integrity of the cleanup work completed at the site or create an exposure to humans or the environment.

A site visit was conducted January 21, 2015, and Ecology determined the following based on the periodic review:

- The cleanup actions are protective of human health and the environment.
- Soil cleanup levels have not been met, but the cleanup action complies with WAC 173-340-740(6)(f) since the long-term integrity of the containment system is ensured and the requirements for containment technologies have been met.

• The covenant for the property is in place and will protect public health and the environment from exposure to hazardous substances and protecting the integrity of the cleanup action.

• No additional remedial actions are required.

Ecology will review all comments received during the comment period and make changes to the periodic review, if appropriate. If no significant changes are made, the review will be finalized. If significant changes are made, no additional public comment period will be held.

GLOSSARY

Agreed order - A legal agreement with Ecology to make sure the cleanup meets the standards of Washington State's cleanup law, the Model Toxics Control Act (MTCA).

Cleanup action plan (CAP) - A document that describes the selected cleanup method(s) and specifies cleanup standards and other requirements. It is based on information and technical analyses generated during the RI/FS and consideration of public comments and community concerns. A draft of the CAP (DCAP) is made available for public review and comment before finalizing.

Comment period - A time period during which the public can review and comment on various documents and Ecology or EPA actions. For example, a comment period is provided to allow community members to review and comment on proposed cleanup action alternatives and proposed plans. Also, a comment period is held to allow community members to review and comment on draft feasibility studies.

Consent decree - A formal legal agreement that is filed with a court. It describes studies and/or cleanup work to be done at a site and the terms under which that work is to be done.

Engineering design report - Engineering design reports outline the specific details for implementation and operation of the first phase of the cleanup actions.

ERTS - Environmental Report Tracking System

Five-year periodic review - A periodic review is conducted at least every five years after the initiation of a cleanup action at a site, as required by the Model Toxics Control Act (MTCA). The purposes of the review are to evaluate site conditions, after cleanup is considered complete, and to ensure protection of human health and the environment.

Hazardous Sites List - A statewide list of contaminated properties. Ecology may remove a site from the list only after determining that all remedial actions except confirmational monitoring have been completed and compliance with the cleanup standards has been achieved at the site, or the listing was erroneous.

Independent cleanup action - Any remedial action without department oversight or approval and not under an order or decree.

LUST - Leaking Underground Storage Tank

NFA - No Further Action

Public participation plan - Outlines and describes the tools Ecology will use to inform the public about site activities, and it identifies opportunities for the community to become involved in this process.

PSI - Puget Sound Initiative

RCW - Revised Code of Washington

Remedial action - Construction work done to clean up a contaminated site.

Remedial investigation/feasibility study - Two distinct but related studies. They are usually performed at the same time, and together referred to as the "RI/FS."

RI/FS - See Remedial Investigation/Feasibility Study

SEPA - State Environmental Policy Act

Site Hazard Assessment (SHA) - An assessment to gather information about a site to confirm whether a release of hazardous substances has occurred and to enable Ecology to evaluate the relative potential hazard posed by the release.

UXO - Unexploded Ordnance

Voluntary Cleanup Program (VCP) - The VCP is one of several options for cleaning up a hazardous waste site under the state's cleanup law. Under this option, property owners may perform a cleanup independently and request services from Ecology for a fee.



WAC - Washington Administrative Code

WARM, Washington Ranking Method - The method used to rank sites placed on the Hazardous Sites List.
