Ecology invites you to comment on a periodic review of post-cleanup conditions and monitoring data for the Weyerhaeuser Chlor Alkali Plant site. It describes institutional controls and ongoing groundwater monitoring currently in place to protect human health and the environment.

The 38.5 acre Weyerhaeuser Chlor Alkali Plant is located on the north shore of the Columbia River, about 2 miles southwest of the city of Longview, in Cowlitz County in southwest Washington. The site produced chlorine and sodium hydroxide for use by the pulp and paper industry from 1958 to March 1999. While cleanup at the site ended in 2003, soil and groundwater contamination remain. Under a 2004 compliance monitoring plan, Weyerhaeuser continues to conduct groundwater monitoring on a periodic basis. Axiall Corporation currently operates the Eagle US2 plant on this site.

Permit Modification Available for Public Review and Comment

Ecology welcomes comments on a draft dangerous waste permit modification for the Stericycle-Kent facility, formerly known as PSC-Kent.

Burlington Environmental LLC is the legal owner of the facility and is a wholly-owned subsidiary of PSC Environmental Services LLC, which is a wholly-owned subsidiary of Stericycle Environmental Solutions Inc.

Stericycle modified the dangerous waste (DW) permit for its facility in Kent. In accordance with WAC 173-303-830, the change is a Class 2 modification requiring Ecology's approval.

Stericycle has submitted a proposal to revise Parts A and B of the Stericycle-Kent facility DW permit to Ecology. These changes reflect construction upgrades and the proposed relocation of various operations to the Stericycle Tacoma facility. New construction will include firewalls, an expanded South Dock, and a concrete driving surface between the South Dock and the warehouse.

Several units will be removed from DW service. These include the South Check-In Area, Lab Pack Area, Lab Pack Container Storage Area, North and South Container Storage Areas, Central Process Area, and Solidification Process Area. No changes will be made to DW tank-related activities.

The modification also describes a change in facility name from "PSC-Kent" to "Stericycle-Kent."

A public meeting will be held on July 29, 2015, at 5 p.m. at the Stericycle-Kent Regional Office, 18000 72nd Ave. S, Ste. 217, Kent.

Documents Related to Prospective Purchaser Consent Decree Available for Public Review and Comment

Touchstone North Lake Union (North site), the North Yard portion of the former Metro Lake Union site, is located at 3301 Densmore Ave. N in Seattle. In 2007, Touchstone entered a legal agreement with Ecology called a prospective purchaser consent decree (PPCD) to define Touchstone's cleanup actions if it purchased the North site. The North site was purchased in 2009. It is the former Metro Lake Union North Yard, approximately one-half of the Metro Lake Union site, and the former Chevron Bulk Petroleum Terminal #100-1327 site at 1602 N Northlake Way, Seattle.

Touchstone has performed the cleanup actions for the North site as required by the PPCD. The petroleum contaminated soils were removed for off-site treatment and/or disposal at an approved facility. Post-excavation soil testing showed all known petroleum soils have been removed from the North site and that remaining soil meets cleanup levels for unrestricted land use.

The North site cleanup actions and post-excavation soil testing results are described in a remediation action report. This site has an environmental restriction limiting groundwater use at the property. Ecology proposes to approve the report and to issue a determination that the requirements of the PPCD have been satisfactorily completed. Ecology invites comments on the following:

Underground storage tanks contaminated site soil and groundwater with petroleum. The tanks were removed in 1998 and the site was cleaned up. Some contamination remains on site. This soil is capped and an environmental covenant prohibits activities that could disturb it.

Based on the 2015 site visit, Ecology determined that the asphalt cap continues to eliminate direct exposure to contamination. No groundwater contamination was detected in the 2014 testing.

Draft Site Reports, Cleanup Action Plan, Agreed Order, and State Environmental Policy Act Determination Available for Comment Ecology invites the public to comment on draft cleanup plans, an agreed order, and a State Environmental Policy Act (SEPA) review for the USG Highway 99 cleanup site. Site groundwater, soil, and sediment are contaminated with arsenic. Under the proposed cleanup plans USG will:

- Remove contaminated sediments from Hylebos Creek.

Stericycle modified the dangerous waste (DW) permit for its facility in Tacoma. In accordance with WAC 173-303-830, the change is a Class 2 modification requiring Ecology's approval. This modification revises Parts A and B of the Stericycle-Tacoma facility DW permit. It now reflects construction and operational changes to accommodate the proposed relocation of various operations from the Stericycle-Kent facility to the Stericycle-Tacoma facility.

New DW units will include the main truck dock, main check-in area, process area #1, process area #2, and the Lab Pack Building. Container management activities at the Tacoma facility will remain within previously approved capacity limits established in a prior permit. No changes will be made to tank-related waste management activities. The modification also describes a change in facility name from "PSC-Tacoma" to "Stericycle-Tacoma."

Proposed Removal of Environmental Covenant

Ecology proposes to remove the environmental covenant from the property associated with the Georgia Pacific Corp Clear Lake site. The site is approximately 5.6 acres of land located at 12827 S. Front St. in Clear Lake (Skagit County Assessor's Parcel: P23293). The environmental covenant was recorded for the property in 2004.

The property was used by the Georgia Pacific Corporation for silviculture operations from approximately 1980 to 2000 and included storage and use of chlordane pesticide. During the early 1990s, the property owner began conducting an environmental investigation on the property that detected petroleum hydrocarbons in soil and chlordane in soil and groundwater above the state's cleanup standards.

The site was cleaned up under Ecology's Voluntary Cleanup Program (VCP). Under the VCP, property owners clean up their property with technical assistance and regulatory review from Ecology. During the VCP cleanup process, Ecology required that the environmental covenant be recorded for the property to restrict the use of groundwater for the protection of human health and the environment.

In the early 1990s, cleanup work conducted on the property included the removal of the above ground and underground petroleum storage tanks, excavating and removing approximately 300 tons of chlordane and petroleum contaminated soil. The groundwater has been tested periodically since 1995. Testing of both groundwater and soil on the property now show this site is in compliance with state cleanup standards.

If the cleanup meets the state cleanup standards under the Model Toxics Control Act, Washington's cleanup law, Ecology will issue a "no further action" determination at the completion of the cleanup. Accordingly, Ecology is proposing to remove the environmental covenant.

Periodic Review Available for Public Review and Comment

You are invited to review and comment on a document called a periodic review for the Manito Shopping Center site. A periodic review is conducted at least every five years after the initiation of a cleanup action at a site, as required by the Model toxics Control Act (MTCA). The purposes of the review are to evaluate site conditions after cleanup is considered complete, and to ensure continued protection of human health and the environment.

The site consists of two parcels. The majority of the site includes a shopping center parking lot and a small portion of the site extends under the commercial building. The businesses include the Manito Tap House, Ross Dress for Less, Republic Pi Pizza, US Bank, and Chase Bank located adjacent to the parking area on the north and east of the site. Washington Trust Bank is on adjacent property to the south.

Contaminants of concern in soil included, tetrachloroethene (PCE), trichloroethene (TCE), chloromethane, PAHs and cPAHs. Additional contaminants were detected but were below levels of concern according to state standards.

Groundwater monitoring for five consecutive quarters through April 2009 indicated there is no contaminated groundwater at the site.

Since limited amounts of cPAHs and solvents remain in soil at levels that do not meet state standards, a covenant was placed on the property to limit how it may be used. The restrictions also limits activities that might interfere with the integrity of the cleanup work completed at the site or create an exposure to humans or the environment.

A site visit was conducted January 21, 2015, and Ecology determined the following based on the periodic review:

• The cleanup actions are protective of human health and the environment.

• Soil cleanup levels have not been met, but the cleanup action complies with WAC 173-340-740(6)(f) since the long-term integrity of the containment system is ensured and the requirements for containment technologies have been met.

• The covenant for the property is in place and will protect public health and the environment from exposure to hazardous substances and protecting the integrity of the cleanup action.

• No additional remedial actions are required.

Ecology will review all comments received during the comment period and make changes to the periodic review, if appropriate. If no significant changes are made, the review will be finalized. If significant changes are made, no additional public comment period will be held.

Guidelines revised for cleanups done under VCP

Ecology has revised Publication 08-09-044, "Guidelines for Property Cleanups under the Voluntary Cleanup Program (VCP)." The guidelines explain how to clean up a property within a larger contaminated site under the VCP. The revisions:

• Correct an error in the description of Figure 3-8 (Section 3.6, Example #2).

• Clarify what type of remedial action work requires a license (Section 5.1.3.3).

GLOSSARY

Agreed order - A legal agreement with Ecology to make sure the cleanup meets the standards of Washington State's cleanup law, the Model Toxics Control Act (MTCA).

Cleanup action plan (CAP) - A document that describes the selected cleanup method(s) and specifies cleanup standards and other requirements. It is based on information and technical analyses generated during the RI/FS and consideration of public comments and community concerns. A draft of the CAP (DCAP) is made available for public review and comment before finalizing.

Comment period - A time period during which the public can review and comment on various documents and Ecology or EPA actions. For example, a comment period is provided to allow community members to review and comment on proposed cleanup action alternatives and proposed plans. Also, a comment period is held to allow community members to review and comment on draft feasibility studies.

Consent decree - A formal legal agreement that is filed with a court. It describes studies and/or cleanup work to be done at a site and the terms under which that work is to be done.

Engineering design report - Engineering design reports outline the specific details for implementation and operation of the first phase of the cleanup actions.

ERTS - Environmental Report Tracking System

Five-year periodic review - A periodic review is conducted at least every five years after the initiation of a cleanup action at a site, as required by the Model Toxics Control Act (MTCA). The purposes of the review are to evaluate site conditions, after cleanup is considered complete, and to ensure protection of human health and the environment.

Hazardous Sites List - A statewide list of contaminated properties. Ecology may remove a site from the list only after determining that all remedial actions except confirmational monitoring have been completed and compliance with the cleanup standards has been achieved at the site, or the listing was erroneous.

Independent cleanup action - Any remedial action without department oversight or approval and not under an order or decree.

LUST - Leaking Underground Storage Tank

NFA - No Further Action

Public participation plan - Outlines and describes the tools Ecology will use to inform the public about site activities, and it identifies opportunities for the community to become involved in this process.

PSI - Puget Sound Initiative

RCW - Revised Code of Washington

Remedial action - Construction work done to clean up a contaminated site.

Remedial investigation/feasibility study - Two distinct but related studies. They are usually performed at the same time, and together referred to as the "RI/FS."

RI/FS - See Remedial Investigation/Feasibility Study

SEPA - State Environmental Policy Act

Site Hazard Assessment (SHA) - An assessment to gather information about a site to confirm whether a release of hazardous substances has occurred and to enable Ecology to evaluate the relative potential hazard posed by the release.

UXO - Unexploded Ordnance

Voluntary Cleanup Program (VCP) - The VCP is one of several options for cleaning up a hazardous waste site under the state's cleanup law. Under this option, property owners may perform a cleanup independently and request services from Ecology for a fee.



WAC - Washington Administrative Code

WARM, Washington Ranking Method - The method used to rank sites placed on the Hazardous Sites List.
