

Proposed Removal from the Hazardous Sites List

The Department of Ecology (Ecology) proposes taking the US DEA OPNTF Lawrence Rd site off the Hazardous Sites List. The site is located at 157 Lawrence Rd in Port Angeles. You can comment on this decision from **June 11 – July 13, 2015**. The box to the right shows where to find:

- A No Further Action Letter that describes and approves the cleanup.
- Background information about the site.

Site Background and Cleanup

In January 2002, Clallam County staff discovered a methamphetamine laboratory operating on the site. The county demolished the meth lab. They properly disposed of hazardous and other waste.

In March 2002, county health and Ecology staff collected samples to test for remaining contamination. Some chemicals associated with petroleum products were found above state cleanup levels.

Over time, the chemicals broke down and dispersed naturally. In August 2014, the formerly-contaminated areas and an adjacent well were sampled. No contamination remains above state cleanup levels. Ecology considers the cleanup complete. The site was cleaned up under the Voluntary Cleanup Program.

What Happens Next

1. Through **July 13, 2015**, Ecology invites you to comment on our decision to remove the site from the Hazardous Sites List.
2. We will respond to comments after the comment period ends. We can require further work based on public comments.
3. The last step is removing the site from the Hazardous Sites List.



What is the Hazardous Sites List?

The Hazardous Sites List includes sites that Ecology has assessed for their potential threat to human health and the environment. Sites must go through cleanup and meet state standards before Ecology can remove them from the list.
