## **Proposed Agreed Order**

The Washington State Department of Ecology (Ecology) is entering into an agreed order with Grays Harbor Historical Seaport Authority (GHHSA) to clean up the tidelands study area of the Weyerhaeuser Sawmill Aberdeen site. This site is generally located at 500 North Custer Street in Aberdeen.

#### **Ecology Wants Your Comments!**

You may comment on this decision from June 25 - July 27, 2015.

The **Agreed Order** is a legal agreement that requires GHHSA to:

- Conduct an investigation of the tidelands study area (see map on page 3). This will describe the nature and extent of contamination in the tidelands.
- Develop a Study Area Investigation and Alternatives Analysis Report. This will summarize the investigation results and evaluate cleanup options for the study area. Any cleanup done for only the tidelands of the site would be considered interim actions because they would only address part of the site.

The **Public Participation Plan** is also available for review. It describes the tools Ecology will use to inform the public and gather feedback.

## The Tidelands Study Area

GHHSA bought the former sawmill complex from Weyerhaeuser in 2013. Part of the agreement was that GHHSA would take responsibility for cleaning up the tidelands adjacent to the property.

There are 14.48 acres of state owned tidelands on the north side of the site along the Chehalis River (see map on page 3). The Washington State Department of Natural Resources (DNR) manages the tidelands. GHHSA subleased the tidelands from Weyerhaeuser in 2013. They are currently negotiating with DNR for a new lease.

#### **Contamination**

In 2013, testing found chemical byproducts of past mill operations on the site. Contaminants include:

- **Dioxins** unintentional byproducts of human activities and natural processes that break down slowly. They can be released through forest fires, burning trash, and industrial activities.
- **Mercury** used in gauges and switches in the sawmill equipment.
- **Petroleum hydrocarbons** diesel and oil used in former mill equipment.
- **Polychlorinated biphenyls (PCBs)** manufactured chemicals that break down slowly in the environment.

Woodwaste was also found in sediments beneath the former over water mill structures

#### Site Background

Sawmills operated on the property since the early 1900s. Weyerhaeuser ran the mill facilities between 1955 and 2009.

In 1924, a mill called the "Big Mill" was built on pilings and decking over the tidelands area. The Big Mill was originally used to make shingles and slats for housing construction. During World War II it was used for making ship keels for the war effort. The Big Mill closed in 2006 and the building was removed by 2010.

## **GHHSA Grants Summary**

In 2013, Ecology issued an integrated planning grant to GHHSA. This grant helps fund the:

- Assessment of contamination in sediment and uplands.
- Formation of a strategy for the new tidelands lease.
- Designing of a market analysis, site plans, and funding strategies for the property.

In 2015, Ecology plans to issue a remedial action grant to GHHSA. This grant will help fund the investigation and development of cleanup alternatives for the tidelands study area.


# How does a polluted site get cleaned up?

- The Remedial Investigation & Feasibility Study (RI/FS) looks at the extent and type of pollution at a site. It evaluates cleanup options and develops alternatives. <u>Currently, GHHSA</u> is only investigating the tidelands study area for this cleanup site.
- Ecology may allow Interim
   Actions to partially clean up a site before the final cleanup plan is complete. If it is decided that interim actions will be used in the tidelands study area, an interim action work plan will be made available for public comment.
- The Cleanup Action Plan
   (CAP) describes the selected
   cleanup methods and how they
   will meet Ecology's cleanup
   standards. The RI/FS report and
   draft CAP are made available
   for public comment. At this time,
   GHHSA is only investigating the
   tidelands study area.
- Cleanup Toxic substances are removed from the site, contained on the site, or treated to make them less toxic.
   Ecology oversees the cleanup and can require that the site be monitored.
- Delisting Ecology keeps track of toxic cleanup sites on the Hazardous Sites List (HSL).
   Once the cleanup is complete, the public will have a chance to comment before the site is removed from the HSL.

## **Seaport Landing**




