## **Unocal Edmonds**

### **Site Location and Background**

The Unocal Edmonds Bulk Fuel Terminal Site is located at 11720 Unoco Road in Edmonds, Washington (see map). The terminal operated from 1923 to 1991. It was used for storing, blending, and distributing petroleum products including gasoline, diesel, and bunker fuel. An asphalt plant operated on the Site between 1953 and the late 1970s.

The Terminal consisted of a dock and an Upper and a Lower Yard. Petroleum products were pumped from marine vessels moored at the dock to storage tanks in the Upper Yard, which was on a hill above the Lower Yard. Products were gravity-fed and pumped to loading racks in the Lower Yard for transport by truck and train to customers.

A number of Interim Actions have been conducted over the years to clean up oil floating on groundwater, remove arsenic-contaminated soil, and remove petroleum-contaminated soil. Removal of petroleum-contaminated soil resulted in cleanup of groundwater. Most of the Site is now clean. Ecology certified the Upper Yard was suitable for residential use in 2003 and the Point Edwards Condominiums were subsequently constructed.

The Interim Action will clean up two remaining areas of contamination. One is the stormwater Detention Basin 2 Area and the other is the vicinity of a Washington State Department of Transportation (WSDOT) storm drain crossing the Site. The Interim Action Work Plan describes how these two areas will be cleaned up.

The Lower Yard's planned future use may be part of a multimodal transportation terminal. This is part of the Edmonds Crossing Project.

### **What Work Will Be Done?**

Petroleum-contaminated soil in the area of Detention Basin 2 will be excavated and sent off-site for disposal. Soil excavation is expected to result in cleanup of groundwater. This excavation activity will include placing temporary dams in Willow Creek to protect it during excavation. Contaminated water produced from the excavations will be treated and discharged to Willow Creek. The discharge will meet requirements of a National Pollutant Discharge Elimination System (NPDES) Permit.

Petroleum-contaminated soil and groundwater in the WSDOT storm drain vicinity will be cleaned up by a Dual-Phase Extraction system. Extraction wells will be used to pump contaminated water

and soil vapor for treatment and discharge. Water will be treated under a NPDES permit and discharged to Willow Creek. Soil vapor will be treated and discharged to the atmosphere under a Puget Sound Clean Air Agency permit. Compliance monitoring will be conducted to assess whether the cleanup is successful, as is expected, or whether additional work needs to be done.

### **When Will Work Begin? What Can Be Expected During the Interim Cleanup?**

The cleanup of Detention Basin 2 is expected to occur from June through September 2016. It will require heavy equipment to excavate the soil and trucks to haul excavated soil away. Air monitoring and dust control measures will be performed. The primary construction noise will be backup horns, which are required for safety.

The Dual-Phase Extraction System will be installed soon after completion of cleanup of Detention Basin 2. Installation will take about 6 weeks. Drill rigs will install extraction wells, conveyance piping will be laid, and an equipment building (containing the DPE equipment) will be brought onsite. The system is expected to operate for about six years. Operation will be quiet.

### **State Environmental Checklist and Determination**

A SEPA checklist and determination of non-significance are included in Appendix H of the Interim Action Work Plan. Ecology has determined that the actions to be taken at the Site will not have a significant environmental impact. Impacts due to construction activities such as truck traffic and noise are being addressed.

### **What Happens Next?**

Once the public comment period ends, Ecology will review all comments and assess whether changes are needed in the Interim Action Work Plan, including the manner in which work will be performed or whether additional work is needed. Once the Interim Action is complete, the need for further work to complete cleanup of the Site will be assessed. A Cleanup Action Plan will be prepared which documents the final cleanup remedy or specifies additional work needed to clean up the Site. There will be an opportunity for the public to comment on the Cleanup Action Plan before it is finalized.

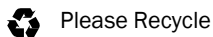
Completion of this Interim Action is anticipated to complete cleanup of the Unocal Edmonds Bulk Fuel Terminal Site.
