Cleanup Work will begin in August at the Truck City Truck Stop

The Department of Ecology (Ecology) will begin cleanup work at the Truck City Truck Stop Site located at 3216 Old Highway 99 South, Mount Vernon, WA. The Truck City Truck Stop facility was developed in 1952. Soil and surface water were historically impacted by several diesel & gasoline releases.

Current data shows only localized ground water impacts within the Site. Sediment sampling in Maddox Creek shows previous impacts have naturally degraded and no longer present.

Construction Hours:

The cleanup work will take place from 7 a.m. – 7 p.m. Monday – Friday. The contractor will comply with all of the City of Mount Vernon ordinances. Contact Darren Ness regarding construction concerns at (206) 678-5122.

What will be done at the site?

This work is being done under a Prospective Purchaser Consent Decree between Ecology and Skagit County to clean up the Site. The cleanup work will involve:

- Excavate & remove petroleum contaminated soil
- Dewatering
- Bioremediation to cleanup petroleum contaminated groundwater
- Demolition of canopies & remove pump islands and product piping
- Removal of current underground storage tanks and fuel lines.

What happens next after the Cleanup?
