

## **Enforcement Order Available for Public Comment**

The Washington Department of Ecology (Ecology) has issued an Enforcement Order for the Jorgensen Forge Site (site) at 8531 East Marginal Way South, Tukwila. This site is west of Boeing Field along the Lower Duwamish Waterway (LDW). An Enforcement Order legally requires cleanup activities without an agreement from the potentially liable person. **Ecology invites public comments on the Enforcement Order.**

### **Why is an Enforcement Order needed?**

Ecology and Jorgensen Forge Corporation (Jorgensen) have been unable to negotiate an Agreed Order (legal agreement). Ecology believes the cleanup actions required by the Enforcement Order are in the public interest.

This Enforcement Order requires Jorgensen to complete a Remedial Investigation (RI) and Feasibility Study (FS) for the site. Ecology will use the RI/FS information to prepare a Draft Cleanup Action Plan (DCAP) and Final Cleanup Action Plan (CAP).

### **Site background**

Investigations have found contaminants above state cleanup levels in site soil and groundwater. These contaminants include polychlorinated biphenyls (PCBs), total petroleum hydrocarbons (TPH), and metals.

In 2007, Ecology and Jorgensen negotiated an Agreed Order to determine if site contamination is a source of LDW sediment contamination. In 2013, Ecology and Jorgensen signed an Agreed Order amendment for an interim action (partial cleanup). This interim action required Jorgensen to remove PCB contaminated soil from a portion of the site. An interim action was conducted but the cleanup goals were not met.

Jorgensen LDW sediments (in-water) are an Environmental Protection Agency Early Action Area. As part of this Early Action Area, Jorgensen removed contaminated sediments from the LDW in 2014.
