The Department of Ecology proposes to adopt amendments to **Chapter 197-11 WAC**, State Environmental Policy Act (SEPA). The rule proposal will be published in the Washington State Register on **March 2, 2016**.

- Create a categorical exemption for the replacement of a City, Town or County owned structurally deficient bridge.
- Make minor updates and clarifications on other transportation related categorical exemptions.
- Make minor updates, clarifications and technical corrections to improve readability.
