Comment period — June 24-July 29, 2016

The Department of Ecology (Ecology) invites you to comment on draft Notice of Construction Order No. 13302 and the associated State Environmental Policy Act Determination of Nonsignificance (DNS) for Longview Fibre Paper and Packaging (doing business as KapStone Kraft Paper Corp.)

Project description

These actions would allow KapStone to install and operate a used Martin Model 924 Flexo Folder Gluer at the box plant. This piece of equipment will make boxes from sheets of corrugated cardboard and print labels on them.

This may increase production of cardboard from the mill and give the box plant the ability to make more boxes than it does currently. Doing this may increase the following air pollutants:

- Volatile organic compounds by up to 0.3 tons per year (TPY)
- Particulate matter (PM) by up to 0.04 TPY of PM10 and 0.015 TPY of PM2.5
- Three toxic air pollutants (acrylic acid by up to 0.003 TPY, styrene by up to 0.00033 TPY, and propylene glycol by up to 0.097 TPY)

These increases do not allow the mill to produce air pollutants at levels higher than what is currently allowed in their air operating permit. Existing air operating permit limits will remain the same.

Commenting

When the comment period ends, we will review all comments received and make appropriate changes before finalizing the documents.

Facility information

The mill, located at 300 Fibre Way in Longview, currently employs about 1,000 people. It produces approximately 3200 tons of pulp and paper products each day.
