Comment period: September 16 - October 17, 2016

The Department of Ecology (Ecology) invites you to comment on the proposed renewal of the State Waste Discharge wastewater permit for Hasa's Longview bleach repackaging plant.

Changes to the permit

Proposed major changes to the permit include:

- Replacing the residual chlorine limit with a best management practice for removal of residual chlorine from the wastewater.
- Increasing the allowed amount of wastewater sent to Nippon's Longview mill from 2,000 gallons to 3,000 gallons each day.

Commenting

Effective comments tell us if we correctly applied current laws, rules and regulations to this action. They:

- Are specific. Tell us what your concern is and how you think the proposed wastewater permit should change.
- Are focused. Refer to the conditions and requirements in the permit.
- Relate to the potential impacts to water quality or sediment from this action. Where possible, describe the state or federal rules and regulations you think have not been applied correctly.

When the comment period ends, we will review all comments received and make appropriate changes before finalizing the documents.

Facility information

Located in Longview at 3400 Industrial Way, Hasa receives sodium hypochlorite (bleach) in bulk tank trucks, off-loads it to bulk storage tanks, and repackages it into one gallon bottles for shipment.

Wastewater is discharged to Nippon Longview's wastewater treatment facility. After treatment, Nippon discharges their wastewater through Outfall 001/002 to the Columbia River.
