

## **Proposed Removal from the Hazardous Sites List Available for Review and Public Comment**

The Washington State Department of Ecology (Ecology) is proposing to remove the Tiger Oil site, located at 16th and East Nob Hill in Yakima, Washington, from its Hazardous Sites List. The Hazardous Sites List is a statewide list of contaminated properties. The site is currently ranked a "1" on the list. A rank of "1" is the highest level of concern compared to other sites on the list, and a rank of "5" is the lowest.

### **Public Comment Invited**

Ecology is asking for your comments on the proposed removal of the Site from the Hazardous Sites List. You are invited to:

- **Review** the *Phase II– Site Assessment Report* and No Further Action determination.
- **Send** your comments to Ecology for consideration. Comments will be accepted *February 3, 2016 through March 4, 2016*

### **Site Background**

Before the site was abandoned, it operated for decades as a retail gas station and bulk fuel storage facility, first by Signal and then by Tiger Oil. Petroleum products were stored underground in large tanks, and then pumped to tanker trucks for delivery to other sites. At least two releases of petroleum products occurred, the first in 1962, when it operated as a Signal station, and the second in 1980, where it was under the ownership of Tiger Oil. Both releases caused concern for nearby drinking water wells. In 1962, replacement drinking water wells were installed. In 1980, nine drinking water wells were found to be contaminated, and the local water treatment plant was shut down for a period of time. Wells were installed to pump out contamination and approximately 10,000 gallons of product was reportedly recovered.

The station stopped operations in 2001. In 2005, 12 underground storage tanks (USTs) were removed from the property. Soil contaminated with gasoline, diesel, solvents, and oil was found in the excavation pit. Petroleum contains many chemicals that are harmful to human health and the environment, including benzene, a known carcinogen, as well as toluene, ethylbenzene, and xylenes.

Cleanup resumed when the City of Yakima purchased the property from Tiger Oil in 2014. Test pits were dug to see how much soil contamination remained. Groundwater monitoring wells were also installed so samples could be taken.

### Why Issue a Decision of No Further Action

Based on previous cleanup activities and current sampling results, Ecology has determined the site does not pose a threat to human health or the environment. Therefore, Ecology has issued a determination of No Further Action and has recommended removing the site from the Hazardous Sites List.

### What Happens Next?

After the public comment period ends, Ecology will review comments received during the comment period. If no changes are necessary, the Site will be removed from the Hazardous Sites List.
