In 2001, Rayonier removed soil contaminated with heavy petroleum products. Some contaminated soil remains at the site.

An environmental covenant is in place for the site. The covenant prohibits activities that could result in the release of contaminants that remain at the site.

Ecology reviews cleanups at least every five years to ensure they protect human health and the environment. This cleanup appears to remain protective of human health and the environment.

*Draft Periodic Review Report available for Public Review and Comment* Ecology invites you to comment on the draft periodic review report for the Hoquiam City Hall cleanup site in Hoquiam. We conduct a periodic review at least every five years after beginning cleanup at a site, as required by the Model Toxics Control Act (MTCA). These reviews evaluate site conditions to ensure continued protection of human health and the environment when institutional controls are used as part of a cleanup.

Historically, the site was contaminated with leaded gasoline near underground storage tanks. The tanks and approximately 486 tons of contaminated soils were removed from the site. Some contaminated soil was left on site. To protect the environment and human health, an asphalt cap and an environmental covenant were put in place to prevent activities on site that could release or expose contaminants. The April 2016 periodic review found that the cleanup actions taken continue to protect the environment and human health.

Ecology will review comments received during the comment period and make recommendations for suggested changes. The periodic review will become final if no significant changes are made. 2016 Cleanup Work at Skykomish School Underway

Cleanup work for 2016 has begun at the Skykomish School, and while the town will not experience disruptions as in past years, there will be some noticeable events happening over the summer. Highlights of cleanup work include:

• Early June: Installation of equipment complete, and the Farallon team begins testing of the equipment and controls. Testing continues through June 15.

• June 15: Hot water flushing operations begin.

• August 17: Hot water flushing ends; cold water flushing begins.

• Early September: Cold water flushing continues to circulate water and remove subsurface oil, until the first large winter storm in October or November. At that time the system will be shut down and winterized to protect from freezing and flooding.

The Farallon and Glacier teams, along with Ecology, will monitor the system continuously throughout operations. Critical alerts and notifications are provided automatically to the School District and Ecology. Operating data is collected continuously and will be freely accessed by the School District through an automated machine interface.

#### Proposed Interim Action Cleanup Plan Available for Public Review and Comment

Ecology invites you to comment on a draft plan for an interim cleanup action, which King County is proposing to conduct on a portion of the Maury Island Open Space cleanup site. While the planning is underway for the overall site cleanup, the proposed interim action will protect the health and safety of park users sooner by eliminating some exposure to contaminants now.

Environmental investigations have shown that contaminants exist throughout the site as a result of fallout from the former ASARCO Tacoma Smelter smokestack, and from former shooting activities in the area. These include arsenic, lead, and polycyclic aromatic hydrocarbons (PAHs) in the soil that exceed levels allowed under the state's cleanup law, the Model Toxics Control Act (MTCA).

Cleanup work will include phased re-vegetation in some areas of the site. Future cleanup plans will identify any additional work needed for the site. All work will be done with Ecology oversight, and under the terms of an agreed order between the county and Ecology.

Ecology invites you to comment on the draft Periodic Review report for the Rite Aid 6232 cleanup site at 12811 Meridian Ave. E in Puyallup. We conduct a periodic review at least every five years after beginning cleanup at a site, as required by the Model Toxics Control Act (MTCA). These reviews evaluate site conditions and ensure continued protection of human health and the environment when institutional controls are used as part of a cleanup.

Historically, the site was contaminated with dinitrotoluene from dynamite. Under Ecology's Voluntary Cleanup Program, and dynamite was detonated or burned, and contaminated soils were removed. Remaining contaminated soils were capped with asphalt and a building.

The March 2016 periodic review found that the building and asphalt cap at the site continue to protect human health and the environment by removing potential for contact with the contamination. An environmental covenant, which restricts land use and development at the site, also protects human health and the environment on the site.

Ecology will review comments received during the comment period and make recommendations for suggested changes. The periodic review will become final if no significant changes are made. An additional public comment period will be held if significant changes are made.

Ecology invites you to comment on the draft Periodic Review report for the Edman Company Side 1 cleanup site in Tacoma. We conduct a periodic review at least every five years after beginning cleanup at a site, as required by the Model Toxics Control Act (MTCA). The purposes of the review are to evaluate site conditions and to ensure continued protection of human health and the environment when institutional controls are used as part of a cleanup.

A waste product called slag from the historic ASARCO smelter in Tacoma was used on the site as ballast to keep heavy equipment from sinking into the soil. That slag contained arsenic, zinc, copper, and lead, which contaminated soil and groundwater at the Edman site.

ASARCO removed contaminated material placed it in a containment cell on the site. Monitoring data showed that contaminants were below the site's cleanup levels in 1998; annual groundwater monitoring continues. In 1996, an environmental covenant was recorded

for the site. The covenant prohibits activities that could result in the release of contaminants contained as part of the cleanup.

The March 2016 periodic review concluded that the cleanup actions remain protective of human health and the environment.

Ecology will review comments received during the comment period and make recommendations for suggested changes. The periodic review will become final if no significant changes are made. An additional public comment period will be held if significant changes are made.

Historic business practices contaminated the Hylebos Waterway with sandblasting grit containing arsenic, copper, and zinc.

Ace Tank cleaned up the site from 1998 - 1999. They removed and disposed of solid materials and debris, sandblast grit and soil and sediments containing sandblast grit. Asphalt caps prevent contact with any remaining upland contamination. An environmental covenant, which restricts activities that could disturb the caps, is in place to further protect the site.

Ecology will review comments received during the comment period and make recommendations for suggested changes. The periodic review will become final if no significant changes are made. An additional public comment period will be held if significant changes are made.

#### Negotiations Underway for Agreed Order

The State of Washington, Ecology and Occidental Chemical Corporation (OCC), Glenn Springs Holding, and Mariana Properties (collectively referred to as potentially liable parties or PLPs) are beginning negotiations on an agreed order to provide for remedial action at Occidental Chemical Corporation's Tacoma site. The order requires the PLPs to:

- Complete a feasibility study.
- Perform pumping tests prior to the completion of the feasibility study.
- Develop and implement a monitoring program in advance of the remedy selection.
- Submit a draft cleanup action plan (dCAP).

Ecology believes the actions required by this oder are in the public interest. Once negotiations have completed, Ecology will provide the draft agreed order for public review and comment.

Ecology proposes to remove the Geiger Heights Housing Area from the Hazardous Sites List, which lists contaminated properties that have been ranked according to their level of potential hazard and their cleanup status. The site is currently ranked a "5" on the list. A rank of "1" is the highest level of concern compared to other sites on the list, and a rank of "5" is the lowest.

The 77-acre site includes 131 single-family and duplex dwellings that were built in the 1950s as housing for the Fairchild Airforce Base. Each unit was heated by fuel oil stored in underground tanks. When the tanks were removed in 1994, nine had leaked oil to soil and groundwater. About 1,755 cubic yards of soil were excavated and disposed offsite, and groundwater monitoring wells were installed and sampled quarterly. The last four consecutive monitoring results met state standards for groundwater.

#### No Further Action

The site was a bulk fuel facility with 25 USTs located on site since at least 1991. The current site owner, City Service Valcon, has occupied the property since 2003. In 1991, 15 USTs were removed from three excavations on the western portion of the property with concentrations of BTEX above cleanup action levels. Impacted soil was left in place.

In 1994, a surface spill resulted in the release of approximately 170 gallons of diesel fuel. Affected soil was removed with heavy-oil soil above cleanup action levels remained at the site. In 1999, seven USTs were removed analogous to the 1991 UST removal activity; however, excavation/soil removal activity did not address previously-identified impacted soil. During the 1999 excavation, approximately 1,200 cubic yards of impacted soil were removed and stockpiled. The 1999 activity was issued an "NFA" determination by Ecology in 2011.

In December 2015, the site underwent confirmation soil boring and sampling activity in December 2015. One sample, B-1 located in the southwestern portion of the site, had a detection of GRPH at a concentration of 11 mg/kg. No other soil samples collected had GRPH concentrations above laboratory detection limits. DRPH, ORPH, and BTEX were not detected in any of the soil samples above laboratory detection limits.

Others who may find it helpful include owners and operators of facilities that experienced petroleum releases; owners of property impacted by petroleum releases from nearby properties; and members of the public.

# **Ecology Revises Policy and Procedure for Identifying PLPs**

Revisions have been made to Policy and Procedure 500A (formerly 500B), which provide Ecology staff guidance and step-by-step instructions on identifying potentially liable persons (PLPs) under the Model Toxics Control Act, Chapter 70.105D RCW.

The updated policy and procedure, including attached template letters, apply to all sites and took effect May 1, 2016.

#### **Overview of Changes**

Policy 500A has been revised to:

- Clarify when and how Ecology will consider liability exemptions, exclusions, and defenses (Section 2).
- Explain how Ecology will interpret and apply the plume clause exemption (Section 3).
- Clarify that Ecology will not certify a person is not liable (Section 4).
- Clarify when during the cleanup process Ecology will search for and identify PLPs (Section 5).
- Clarify and update as needed the remaining provisions in the Policy.

Procedure 500A has been revised to:

- Update and clarify the steps in the Procedure to provide better direction to staff.
- Standardize the format of and plain talk the template letters attached to the Procedure.
- Update the "Final PLP Status letter" template (Attachment F).

# **Checkists, Template Guide Remedial Action Plans and Reports**

Ecology's Toxics Cleanup Program (TCP) has developed new checklists and a suggested template to help you prepare remedial action plans and reports. They are meant to:

- Clarify Ecology's expectations about what needs to be included in the documents.
- Improve the quality and consistency of the documents.
- Expedite our review of the documents.

The checklists for the following remedial action reports and plans are intended to be broadly applicable to sites with varying degrees of complexity. The checklists should be used at all sites, whether they are cleaned up independently or under Ecology supervision:

- Remedial Investigation Report Checklist
- Feasibility Study Report Checklist
- Cleanup Action Plan Checklist

#### **Suggested Template**

A suggested template has been developed for Remedial Investigation reports. The template mirrors the corresponding checklist and provides more information, with suggestions and links to existing guidance materials. We encourage you to use the template, but it is not required.

#### **Voluntary Cleanup Program**

Starting June 1, 2016, independent remedial action plans and reports submitted for Ecology review under the Voluntary Cleanup Program (VCP) need to include the information specified in the applicable checklist. Due to overwhelming demand for staff services under the VCP, Ecology will not accept a plan or report for review until it is complete. If a plan or report is incomplete, Ecology will notify you in writing within 90 days and identify deficiencies using the applicable checklist.

### **GLOSSARY**

Agreed order - A legal agreement with Ecology to make sure the cleanup meets the standards of Washington State's cleanup law, the Model Toxics Control Act (MTCA).

**Cleanup action plan (CAP)** - A document that describes the selected cleanup method(s) and specifies cleanup standards and other requirements. It is based on information and technical analyses generated during the RI/FS and consideration of public comments and community concerns. A draft of the CAP (DCAP) is made available for public review and comment before finalizing.

**Comment period** - A time period during which the public can review and comment on various documents and Ecology or EPA actions. For example, a comment period is provided to allow community members to review and comment on proposed cleanup action alternatives and proposed plans. Also, a comment period is held to allow community members to review and comment on draft feasibility studies.

**Consent decree** - A formal legal agreement that is filed with a court. It describes studies and/or cleanup work to be done at a site and the terms under which that work is to be done.

**Engineering design report** - Engineering design reports outline the specific details for implementation and operation of the first phase of the cleanup actions.

ERTS - Environmental Report Tracking System

**Five-year periodic review** - A periodic review is conducted at least every five years after the initiation of a cleanup action at a site, as required by the Model Toxics Control Act (MTCA). The purposes of the review are to evaluate site conditions, after cleanup is considered complete, and to ensure protection of human health and the environment.

**Hazardous Sites List** - A statewide list of contaminated properties. Ecology may remove a site from the list only after determining that all remedial actions except confirmational monitoring have been completed and compliance with the cleanup standards has been achieved at the site, or the listing was erroneous.

Independent cleanup action - Any remedial action without department oversight or approval and not under an order or decree.

LUST - Leaking Underground Storage Tank

NFA - No Further Action

**Public participation plan** - Outlines and describes the tools Ecology will use to inform the public about site activities, and it identifies opportunities for the community to become involved in this process.

PSI - Puget Sound Initiative

RCW - Revised Code of Washington

Remedial action - Construction work done to clean up a contaminated site.

**Remedial investigation/feasibility study -** Two distinct but related studies. They are usually performed at the same time, and together referred to as the "RI/FS."

RI/FS - See Remedial Investigation/Feasibility Study

SEPA - State Environmental Policy Act

**Site Hazard Assessment (SHA)** - An assessment to gather information about a site to confirm whether a release of hazardous substances has occurred and to enable Ecology to evaluate the relative potential hazard posed by the release.

TCP - Ecology's Toxics Cleanup Program

**Total petroleum hydrocarbons (TPH)** - A term used to describe a large family of several hundred chemical compounds that originally come from crude oil. TPH is a mixture of chemicals made mainly from hydrogen and carbon.

UXO - Unexploded Ordnance

**Voluntary Cleanup Program (VCP)** - The VCP is one of several options for cleaning up a hazardous waste site under the state's cleanup law. Under this option, property owners may perform a cleanup independently and request services from Ecology for a fee.

WAC - Washington Administrative Code

WARM, Washington Ranking Method - The method used to rank sites placed on the Hazardous Sites List.
