7 Eleven Food Store 230325983H

The Washington Department of Ecology (Ecology) invites you to comment on the removal of the 7 Eleven Food Store site off the Hazardous Sites List. The box on the left shows where you can find a No Further Action letter that describes how cleanup is complete.

Site Background and Cleanup

From 1984 to 2014, the site was a gas station located at 3541 Martin Way East in Olympia. In June 1995, while upgrading the gas piping, they found a leaking dispenser. The site was then put on the Hazardous Sites List. The soil and groundwater near the dispensing area was polluted with petroleum hydrocarbons and related volatile organic compounds.

In 2014, all of the gas storage tanks and gas structures were removed along with a total of 1,393 tons of petroleum contaminated soil. Currently, the site is a paved parking lot for the 7 Eleven food store.

After cleanup, we did not find any of the contaminants listed above in the groundwater. However, we did find lead in a few groundwater samples.

After more testing, we found that the lead likely came from soil in those samples rather than the water. The level of lead we found in the soil was far below the cleanup level, and the level does not affect drinking water. Ecology considers cleanup complete.

What Happens Next?

- After the comment period ends, Ecology will respond to any comments.
- We may require further sampling or cleanup based on information given by the public. Otherwise, we will remove the site from the Hazardous Sites List.



What is the Hazardous Sites List?

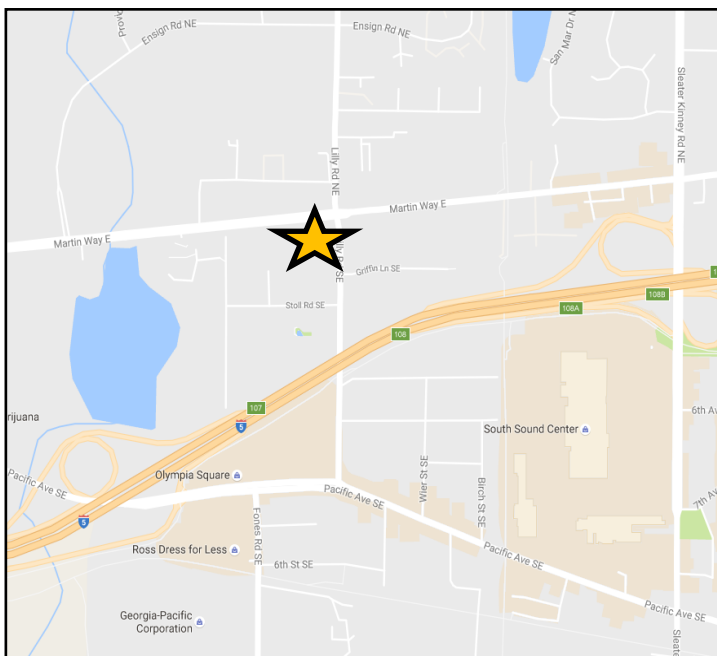
After Ecology has determined a site's potential threat to human health and the environment, it is placed on this list. Sites must go through cleanup and meet state standards before Ecology can remove them from the list.
