Proposed Removal from Ecology's Hazardous Sites List & Removal of Environmental Covenant

You are invited to comment on the proposed removal of the Groat Brothers, Inc. cleanup site from Ecology's Hazardous Sites List.

The purposes of the review are to evaluate site conditions and ensure continued protection of human health and the environment, when institutional controls are used as part of a remedy. Ecology will review comments received during the comment period and make recommendations for suggested changes. The periodic review will become final if no significant changes are made. An additional public comment period will be held if significant changes are made.

In 2002, petroleum contamination was found in site soil and groundwater. Cleanup moved forward under the **Voluntary Cleanup Program**. About 3,500 cubic yards of contaminated groundwater were removed from the site. Groundwater was monitored from 2002 to 2010. In 2004, an environmental covenant was recorded for the site which prohibits activities that could result in the release of contaminants remaining on site.

Based on the results of five rounds of groundwater monitoring from October 2014 through February 2016, Ecology determined that the cleanup was successful and no further actions were necessary and the environmental covenant is no longer needed.

The No Further Action letter is available for your review. It is a technical letter that describes what was done to clean up the site and how we confirmed that the cleanup was successful.

State Environmental Policy Act and Determination of Non-Significance and Checklist

The Port of Seattle Terminal 30 site is on the shoreline of the East Waterway near the mouth of the Lower Duwamish Waterway. The Department of Ecology proposed cleanup actions at the site and held a public comment period on the draft Cleanup Action Plan and Consent Decree 5/18/15-6/19/15. The proposed cleanup

actions include installation of an air sparging/soil vapor extraction system, product recovery, and monitoring. Ecology is now holding another 30-day comment period on its State Environmental Policy Act (SEPA) Checklist and Determination of Non-Significance (DNS) for the proposed cleanup actions.

Ecology is the SEPA lead agency for the Terminal 30 Site cleanup. Based on information provided in the remedial investigation and feasibility study reports, Ecology determined that the proposed actions will not have probable significant adverse impacts on the environment and issued a DNS. Ecology will not act on the DNS proposal until the 30-day comment period is over and Ecology has reviewed all comments regarding the SEPA checklist and DNS.

Interim Action

Ecology invites public comment on the following documents:

- Interim Action Work Plan
- State Environmental Policy Act (SEPA) Checklist and Determination of Non-Significance (DNS)

Tyee Lumber and Manufacturing used the site for lumber re-sawing, finishing, refuse burning, and wood treating from 1929 through the 1980s. The Whitehead Company and Reliable Transfer & Storage owned the property from 1986 to 2015. The current owner is 730 Myrtle LLC. Seattle Iron & Metals Corporation (SIM) has used the site for storing trucks, trailers, bins, and scrap metal equipment the mid-1990s.

Contamination on this property is the result of industrial activity since 1929. Contaminants of concern in soil and groundwater include Total Petroleum Hydrocarbons (TPH) and Pentachlorophenol (PCP).

Under a water quality order, SIM is required to install a stormwater treatment system on the property. This will reduce contamination that runs off the site into the Lower Duwamish Waterway.

SIM and 730 Myrtle, LLC (the potentially liable persons) will conduct an Interim Action to remove contaminated soil in the area where the system is installed. They will also grade and pave the gravel lot to reduce dust and allow stormwater capture.

Ecology has determined that this Interim Action will create no significant adverse impacts to the environment. Therefore, Ecology recommends a State Environmental Policy Act (SEPA) determination of non-significance (DNS) for this activity.

Negotiations Underway for Agreed Order

Ecology is negotiating an agreed order with the Port of Tacoma, Occidental Chemical Corporation, Stericycle Environmental Solutions, Inc., and General Metals of Tacoma to develop and implement a Remedial Investigation/Feasibility Study (RI/FS) Work Plan, perform quarterly groundwater monitoring and well installation, and prepare the RI/FS Report and draft Cleanup Action Plan. Negotiations began on January 18, 2017.

As stated in WAC 173-340-530(5), discussions on the agreed order shall not exceed sixty days unless the department decides that continued discussion are in the public interest. The 60-day deadline is March 19. When agreed order negotiations have been completed, a public comment period will be scheduled. The dates for the public comment period will be announced in a future Site Register. Please direct questions to cleanup project manager Steve Teel.

Unpermitted landfill operations and releases from various hazardous waste treatment, storage, and disposal facilities caused soil and groundwater contamination. The site's soil and/or groundwater are contaminated with total petroleum hydrocarbons, volatile organic compounds, semi-volatile organic compounds, polychlorinated biphenyls, pesticides, and metals at concentrations that exceed state cleanup levels. In addition, the site's indoor air may contain concentrations of one or more volatile organic chemicals that exceed cleanup levels, and methane concentrations represent a potential fire and/or explosion hazard for buildings and subsurface structures at the site.

Negotiations Underway for Agreed Order

Ecology and the current property owners of 3120 S Pine Street and 3102 S Pine Street (formerly adjoined as 3133 S Cedar Street) are negotiating an agreed order to conduct a remedial investigation of a historic release of hazardous substances, prepare a feasibility study to evaluate cleanup options for the release, and to develop a draft cleanup action plan describing the selected cleanup action. The properties were the former location of the Buffelen Pipe and Creosote Company/American Wood Pipe Company, which operated in the early 1900s. The hazardous substances identified at this time primarily consist of creosote related compounds and have been found in soil and groundwater.

Negotiations began on January 12, 2017 and are anticipated to conclude by March 13, 2017.

Proposed Removal from Ecology's Hazardous Sites List & Removal of Environmental Covenant

Ecology invites you to comment on the proposed removal of the Interlake Grocery cleanup site from Ecology's Hazardous Sites List. The Hazardous Sites List is a statewide record of contaminated properties. Comments are also invited for a proposed removal of the environmental covenant for this site. Environmental covenants limit activities on a site to prevent accidental releases of contamination.

For several decades, a gas station has operated on this property. During that time, gasoline leaked from underground storage tanks into soil and groundwater on the site.

The property owners worked with Ecology under the **Voluntary Cleanup Program** to remove contaminated soil and monitor the groundwater. Several soil and groundwater tests conducted in the 1990s and again in 2016 showed that the groundwater and soil cleanup was successful. Ecology has determined that no further cleanup action is necessary and the environmental covenant is no longer necessary.

GLOSSARY

Agreed order - A legal agreement with Ecology to make sure the cleanup meets the standards of Washington State's cleanup law, the Model Toxics Control Act (MTCA).

Cleanup action plan (CAP) - A document that describes the selected cleanup method(s) and specifies cleanup standards and other requirements. It is based on information and technical analyses generated during the RI/FS and consideration of public comments and community concerns. A draft of the CAP (DCAP) is made available for public review and comment before finalizing.

Comment period - A time period during which the public can review and comment on various documents and Ecology or EPA actions. For example, a comment period is provided to allow community members to review and comment on proposed cleanup action alternatives and proposed plans. Also, a comment period is held to allow community members to review and comment on draft feasibility studies.

Consent decree - A formal legal agreement that is filed with a court. It describes studies and/or cleanup work to be done at a site and the terms under which that work is to be done.

Engineering design report - Engineering design reports outline the specific details for implementation and operation of the first phase of the cleanup actions.

ERTS - Environmental Report Tracking System

Five-year periodic review - A periodic review is conducted at least every five years after the initiation of a cleanup action at a site, as required by the Model Toxics Control Act (MTCA). The purposes of the review are to evaluate site conditions, after cleanup is considered complete, and to ensure protection of human health and the environment

Hazardous Sites List - A statewide list of contaminated properties. Ecology may remove a site from the list only after determining that all remedial actions except confirmatory monitoring have been completed and compliance with the cleanup standards has been achieved at the site, or the listing was erroneous.

Independent cleanup action - Any remedial action without department oversight or approval and not under an order or decree.

LUST - Leaking Underground Storage Tank

NFA - No Further Action

Public participation plan - Outlines and describes the tools Ecology will use to inform the public about site activities, and it identifies opportunities for the community to become involved in this process.

PSI - Puget Sound Initiative

RCW - Revised Code of Washington

Remedial action - Construction work done to clean up a contaminated site.

Remedial investigation/feasibility study - Two distinct but related studies. They are usually performed at the same time, and together referred to as the "RI/FS."

RI/FS - See Remedial Investigation/Feasibility Study

SEPA - State Environmental Policy Act

Site Hazard Assessment (SHA) - An assessment to gather information about a site to confirm whether a release of hazardous substances has occurred and to enable Ecology to evaluate the relative potential hazard posed by the release.

TCP - Ecology's Toxics Cleanup Program

Total petroleum hydrocarbons (TPH) - A term used to describe a large family of several hundred chemical compounds that originally come from crude oil. TPH is a mixture of chemicals made mainly from hydrogen and carbon.

UXO - Unexploded Ordnance

Voluntary Cleanup Program (VCP) - The VCP is one of several options for cleaning up a hazardous waste site under the state's cleanup law. Under this option, property owners may perform a cleanup independently and request services from Ecology for a fee.

WAC - Washington Administrative Code

WARM, Washington Ranking Method - The method used to rank sites placed on the Hazardous Sites List.
