State Environmental Policy Act and Determination of Non-Significance and Checklist

The Port of Seattle Terminal 30 Site (Site) is located at 1901 East Marginal Way South, Seattle, Washington about one mile southwest of downtown Seattle, in King County, Washington. The Site is on the shoreline of the East Waterway near the mouth of the Lower Duwamish Waterway.

The Department of Ecology (Ecology) proposed cleanup actions at the Site and held a public comment period on the draft Cleanup Action Plan and Consent Decree between May 18 - June 19, 2015. The proposed cleanup actions include installation of an air sparging/soil vapor extraction system, product recovery, and monitoring.

Ecology is now holding another 30 day comment period on its State Environmental Policy Act (SEPA) Checklist and Determination of Non-Significance (DNS) for the proposed cleanup actions. The comment period will be from February 10-March 13, 2017.

Ecology is the State Environmental Policy Act lead agency for the Terminal 30 Site cleanup. Based on information provided in the remedial investigation and feasibility study reports, Ecology determined that the proposed actions will not have probable significant adverse impacts on the environment and issued a DNS. Ecology will not act on the DNS proposal until the 30 day comment period is over and Ecology has reviewed all comments regarding the SEPA checklist and DNS.

After the 30-day comment period, Ecology will review and respond to the comments received. If no significant changes are made, the SEPA Checklist and DNS will become final. The proposed cleanup is scheduled to begin in 2018.
