The Yard Program: An Introduction

You are receiving this newsletter, because your yard qualifies for soil replacement. For nearly 100 years, the Asarco Company operated a copper smelter in Tacoma. Air pollution from the smelter settled on the surface soil over more than 1,000 square miles of the Puget Sound basin. Arsenic, lead, and other heavy metals are still in the soil as a result of this pollution.

The Department of Ecology (Ecology) offers soil replacement through the Residential Yard Sampling and Cleanup Program (Yard Program). Soil sampling results and Yard Program paperwork can be found by going to our public database:


The Capital Budget and Yard Program funding

The funding for the Yard Program is from a bankruptcy settlement with the Asarco company. The money sits in the Cleanup Settlement Account, which is a capital budget item. Every two years the legislature must approve Ecology's request to spend the funds. This year the capital budget was not passed, and we did not receive any new funding.

Ecology did receive a re-appropriation of the money we did not spend last biennium. We also received money from the Environmental Protection Agency (EPA) to replace soil in yards with arsenic over 230 ppm. These funds allow us to work on a small group of yards this year, and plan for another small group early next year.

In 2018, we will request a supplemental budget to fund our work through the end of the 2017-2019 biennium cycle. We hope to know by early summer if we receive new funding. When we do, we will proceed with our work. At this time, we are pausing most of our construction work.





Soil replacement progress and updates

We found 1,181 yards that qualify for soil replacement, and we completed work on 228 yards. For the next two years, with slow-downs around the capital budget, we project we are able to complete soil replacement on 30-60 yards each year. When funding becomes available again, our goal is to work with 80-100 yards each year.

It may be several years (3-7 years) before we are able to meet with you to discuss soil replacement. We are working neighborhood by neighborhood to address the most contaminated areas of the plume. OUR YARDS, OUR HEALTH

What Healthy Actions can we practice to protect ourselves?



- Don't track arsenic and lead into your home—take shoes off!
- If children crawl or play on the floor in your home, dirt can get on their hands and in their mouths.
- Vacuum and damp dust often.
- Keep children's toys, teethers, and pacifiers clean, to keep dirt off hands and out of mouths.



 Wear gloves and shoes when you garden.
Take them off and wash your hands well




- Wear a dust mask when mowing in dry conditions.
- **Wet** dry soil when working in garden beds to avoid breathing in dust .



 Wipe pet's paws when they come inside, whether wet or dry.



- **Grow** fruits and vegetables in raised beds with clean soil.
- Wash all fruits and vegetables before eating.
- Peel root vegetables like carrots and potatoes.
