# Comment period: Dec. 12, 2018 - Jan. 16, 2019

We invite you to comment on a draft State Waste Discharge water quality permit for the Tesoro Logistics facility in Anacortes.

Co-located with the Marathon/Andeavor/Tesoro oil refinery at 7969 North Texas Road, Tesoro Logistics offloads and stores crude oil from rail cars, loads and stores oil products, and operates a wharf.

It sends wastewater and stormwater to the refinery for treatment before discharge to the north end of Fidalgo Bay.

## **Permit requirements**

The proposed permit includes requirements to:

- Monitor wastewater flow.
- Check weekly for oil and grease at the crude railcar off-loading facility.
- Update the facility's spills plan.
- Submit documents, such as monitoring reports, electronically.

# Commenting

Effective comments tell us if we correctly applied current law, rules, and regulation to this draft permit. They:

- Are specific. Tell us what your concern is and how you think we should change the permit.
- Are focused. Refer to sections or parts of the permit and relate these potential impacts to water quality.
- Describe the state or federal rules and regulations you think have not been applied correctly.

When the comment period ends, we will review all comments received and make appropriate changes to the permit before issuing it.
