You're invited to comment on plans to cleanup this site. This is one of 11 cleanup sites located on the waterfront along Port Gardner Bay that have been prioritized for cleanup under that State's Puget Sound Initiative. Details on where to review documents and send comments are provided on the left. The following draft documents are available for your consideration:

- Amended Agreed Order
- Interim Action Work Plan
- State Environmental Protection Act (SEPA) determination of non-significance (DNS)

Send your comments by November 5, 2018. A public meeting will be held if 10 or more people request one during this comment period.

### Site Background

The Site, at 1032 West Marine View Drive, was formerly used as a shingle mill, fiberglass boat construction company, and boat part manufacturer. TC Systems, Inc. and its previous owners, Marpac and Tri-Coatings, operated at the Site from 1980 to 2010. In 2010, The Amended Agreed Order for site cleanup includes a work plan to study the type and extent of site contamination. Soil samples were tested from 2011 to 2015. Results revealed primary contaminants including petroleum hydrocarbons, polycyclic aromatic hydrocarbons, polychlorinated biphenyls, and arsenic levels above the state's cleanup levels.

The draft amended Agreed Order and Interim Action Work Plan focus on digging out soil for replacement of 300 feet of stormwater trunkline along a section of the southern edge of the site. The DNS identifies no significant environmental impacts from this effort.
