Public Comment Invited

The Department of Ecology (Ecology) proposes taking the Today's Family Dentistry site off the Hazardous Sites List. The site is located at 2616 NE 112th Ave in Vancouver. Ecology invites your comments about this proposal from December 24, 2018 to January 25, 2019.

The box on the left shows where you can find the No Further Action (NFA) letter explaining Ecology's opinion that no more cleanup work is required.

Background and Cleanup

In 2010, Clark County Public Health and Ecology tested the on-site septic tank and found it had waste metals typical of a dental office. Based on early sampling information, Ecology put the site on the Hazardous Sites List. To follow-up, in 2017 the property owner put four groundwater monitoring wells on the property to see if metals had moved to the soil and groundwater. Results showed that metals were below state cleanup levels.

The property owner, who had entered the Voluntary Cleanup Program, conducted the following cleanup activities at the site:

- Tested and removed septic tank sludge.
- Removed the septic tank from the property.
- Connected the building to the city sewer system.

Ecology reviewed the cleanup work and determined that the site meets state cleanup levels.

What is the No Further Action Letter?

Ecology's Voluntary Cleanup Program gives advice to the property owners, who clean up a site on their own. The NFA letter is Ecology's opinion that the cleanup is complete.

Next Steps

After the comment period ends, Ecology will respond to comments and post the responses online on the site webpage. Ecology may withdraw the No Further Action determination based on comments given during the comment period. Otherwise, Ecology will remove the site from the Hazardous Sites List.



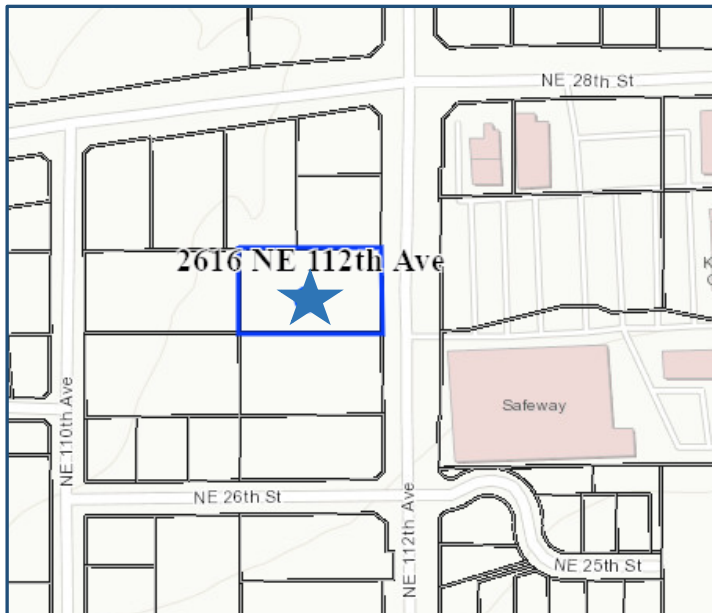
What is the Hazardous Sites List?

The Hazardous Sites List includes sites that Ecology has rated for their relative potential threat to human health and the environment. Sites must meet state cleanup levels and include a public comment period before Ecology can remove sites from the list.
