Comment period: June 10 – July 11, 2019

We invite you to comment on the following proposed air quality actions for the Nippon Dynawave pulp and paper mill in Longview.

- Notice of Construction Order No. 16181, and the associated State Environmental Policy Act (SEPA) Determination of Nonsignificance
- Modified Air Operating Permit (AOP) 0000124

These would allow an increase to emission limits at the mill's Extruders Operation.

Project information

The extruders apply a polymer to the surface of paperboard to make liquid packaging containers (such as milk cartons and paper cups).

The proposed changes are a result of updated air pollution emissions information and do not include physical changes to the extruder operations.

The changes will allow increases of pollution from the extruder operations by the following amounts:

- Particulate matter above 10 microns in size (PM10) by 1 pound per hour (lb/hr)
- PM2.5 by 0.1 lb/hr
- Volatile organic compounds by 4.5 lbs/hr, and 19.7 tons per year (tpy)

As long as all applicable requirements are met, these increases are allowed under air quality standards.

If we determine there is significant public interest during this comment period to hold a hearing, we will extend the comment period to allow at least 30 days notice and publish the time, date and location of the hearing.

When the comment period ends, we'll review the comments received and make a final decision, which may include changes to the order.
