We invite you to comment on the following proposed Air Operating Permit (AOP) modification for Packaging Corporation of America (formerly Boise White Paper).

Changes to the Permit

Changes to the permit include:

- A change in ownership at the facility.
- Incorporating permit conditions related to the previously permitted (Prevention of Significant Deterioration Permit 18-01 and Notice of Construction Order No.15783) increase in daily capacity of Paper Machine #3 and the No. 2 M&D Digester.
- Incorporating updates to the National Emission Standards for Hazardous Air Pollutants (NESHAPS) in 40 CFR Part 63 Subpart MM.
- Some other administrative changes.

As long as all applicable requirements are met, these increases are allowed under air quality standards.

Commenting

Your request must include your interest in the permits and reasons why a hearing should be held.

If we determine there is significant public interest during this comment period to hold a hearing, we will extend the comment period to allow at least 30 days notice and publish the time, date and location of the hearing.

When the comment period ends, we will review the comments received and make a final decision, which may include changes to the order.

Facility information

Located at 13831 US Highway 12 in Wallula, this facility is a kraft paperboard mill and corrugated container plant. It's capable of making about 1,800 tons of paper product and approximately 5 million square feet of corrugated boxes each day.
