We invite you to comment on the following proposed air quality actions for the Georgia-Pacific paper mill in Camas.

- Administrative Order 16879.
- Modified Notice of Construction (NOC) Order DE-1147-AQ04 and adoption of a previous State Environmental Policy Act (SEPA) determination of nonsignificance (DNS).
- Modified Air Operating Permit (AOP).

The mill has shutdown its operations with the exception of one paper machine and the boilers that power it.

Administrative Order 16879

The order would allow the mill to claim an air pollution emission reduction credit based on the shutdown of many of its emission units (pieces of equipment that release air pollution when operating).

Changes to the NOC Order

The proposed changes to this order remove some requirements and monitoring that were based on operations that are now shut down. No increases in air pollution are allowed by the proposed changes.

Changes to the AOP

Proposed changes include:

- Incorporating the two orders above.
- Changing the name of the facility.
- Removing requirements that are no longer necessary due to the shutdown of much of the mill.

Commenting

Effective comments tell us if we correctly applied current laws, rules, and regulations to these actions. They:

- Are specific. Tell us what your concern is and how you think the orders and/or permit should change.
- Are focused. Refer to conditions and requirements in the orders and/or permit.
- Describe the state or federal rules and regulations you think have not been applied correctly.

Your request must include your interest in the orders/permit and reasons why a hearing should be held.

If we determine there is significant public interest during this comment period to hold a hearing, we will extend the comment period to allow at least 30 days notice and publish the time, date and location of the hearing.

When the comment period ends, we'll review the comments received and make a final decision.
