Site Background

Albert Jensen & Sons Inc. Site (site), located at 1293 Turn Point Road in Friday Harbor, WA, was historically used for boat building and maintenance as early as 1910. Today, the site is still used as a boat maintenance facility and shipyard with a boat pullout and wash station onsite. Decades of industrial use have contributed to contamination in the soil and marine sediment at the site.

The Port of Friday Harbor (the Port) recently purchased the site from Albert Jensen & Sons with the intent to redevelop the site and address existing environmental concerns. Ecology plans to work with the Port to design and implement a cleanup plan for the site. Recent sampling of the upland soil and marine sediment at the site identified tributyltin (TBT), polychlorinated biphenyls (PCBs), dioxins/furans, phthalates, organic chemicals, pesticides, polycyclic aromatic hydrocarbons (PAHs), and metals.

Ecology and the Port are preparing to enter into an Agreed Order to provide remedial action and additional soil, groundwater and sediment investigations for cleanup at the site.
