Documents available for public comment

Three documents are available for public review and comment for the Weyerhaeuser Sawmill in Aberdeen, Washington (site).

Agreed Order DE 15953. The Washington Department of Ecology (Ecology) is entering into a legal agreement called an Agreed Order with Grays Harbor Historical Seaport Authority (GHHSA) to study contamination at the site. The Order requires GHHSA to use past investigations and close any data gaps to develop the following reports:

- A remedial investigation (RI), which describes the types and extent of contamination.
- A feasibility study (FS), which considers and compares cleanup options.
- A draft cleanup action plan (CAP), which identifies cleanup methods.

The Agreed Order allows GHHSA to clean up parts of the site before the final cleanup plan is complete. We will hold a public comment period if any partial cleanups (called interim actions) are proposed.

Removal of an environmental covenant. The environmental covenant, which restricts access to soil and groundwater was placed on the wrong parcel in the 1990s after cleanup was done on part of the site. GHHSA proposes to remove the covenant and clean up the site so there will be unrestricted land use. If needed, a new covenant will be placed as part of the CAP.

Public Participation Plan. The plan describes how Ecology will inform the community about site activities and opportunities to be involved in the cleanup process.

Site background

The site consists of several parcels of land generally located at 500 North Custer Street where there was a sawmill complex. It includes upland properties and 14.48 acres of state-owned tidelands managed by the Department of Natural Resources.

From the early 1900s, the site was used for sawmills and other forest product industries. Weyerhaeuser Company operated two sawmills, steam drying kilns, and wood refuse burners between 1955 and 2013. Additional activities included wood chipping and barge loading. GHHSA acquired the parcels from Weyerhaeuser in 2013 and agreed to take responsibility for cleaning up any legacy environmental contamination.


The nearby Chehalis River and Grays Harbor is within the Usual and Accustomed fishing grounds of the Quinault Indian Nation. Quinault tribal members harvest salmon and other treaty fisheries resources in this area.

GHHSA is a municipal Public Development Authority created by the City of Aberdeen in 1986. A key element of their mission is to create a local and regional recreation and tourism destination and a homeport for the Lady Washington and Hawaiian Chieftain tall ships. Acquiring the property, which includes a wharf and docks for the ships, was an important step in accomplishing that goal. Addressing environmental contamination at the site is important to bring the property into full productive use.

investigations and cleanup work have taken place since the 1980s. Ecology reopened the investigation in 2014 for further study due to the discovery of previously unknown contamination. The recent investigations (see Figure 1) identified many potential sources and contaminated areas. These include Shannon Slough, former maintenance areas, chemical and hazardous material storage buildings, buildings used to treat lumber, and above- and belowground storage tanks (see Figure 2).

The following contaminants are suspected to be found in sediments, soil, or groundwater:

- Benzoic acid
- Mercury
- Pentachlorophenol (PCP)
- Dioxins

- Polychlorinated biphenyls (PCBs)
- Polycyclic aromatic hydrocarbons (PAHs)
- Petroleum hydrocarbons (TPHs)
- Phenol

- Wood waste
- Metals (chromium, lead, copper, and manganese)
- Volatile organic compounds (VOCs)

The presence of these materials above state sediment, soil, and groundwater cleanup standards can be harmful to human health and the environment.



Next steps

Ecology will consider your comments before the Agreed Order, document for the proposed removal of the environmental covenant, and Public Participation Plan are finalized. We will reply to comments in a responsiveness summary after the comment period ends.


