We invite you to comment on the changes to the National Pollutant Discharge Elimination System water quality permit for Solvay Chemicals in Longview.

Changes to the permit

We propose to modify the permit to allow an increase in the daily maximum flow rate limit to the Three Rivers Regional Wastewater Authority (TRRWA).

Solvay is currently allowed to send (discharge) up to 287,000 gallons each day to the TRRWA through Outfall 001A. The change would allow Solvay to increase its discharge up to 353,190 gallons each day. Ecology verified that the TRRWA treatment system had the capacity to accept the proposed increase, including any associated pollutant increases.

We also made some administrative updates. A detailed list of changes, and why they're needed, is available in the modification's support document.

Commenting

Effective comments tell us if we correctly applied current laws, rules, and regulations to this action. They:

- Are specific. Tell us what your concern is and how you think the permit should change.
- Are focused. Refer to the changes to the conditions and requirements in the permit.
- Describe the state or federal rules and regulations you think have not been applied correctly.

When the comment period ends, we'll review the comments received and make a final decision.
