#### Comment period: May 29, 2020 - June 29, 2020

We invite you to comment on the draft Notice of Construction Order No.17965 and the associated State Environmental Policy Act (SEPA) Determination of Nonsignificance for Packaging Corporation of America (PCA) pulp and paper mill's project to build a new recycled fiber plant and to increase production at the No.2 Paper Machine (No.2 PM).

### **Project Information**

The proposed project will allow PCA to increase their capacity to process recycled fibers into new products. The project would replace an existing double-lined kraft (DLK) clippings repulping plant with a new recycled fiber plant (RFP) and would modify the No.2 Paper Machine (PM) to accommodate the increase in pulp production. The new RFP plant would increase the recycled pulping capacity of the facility by 875 air dried tons of pulp per day (ADTPD). The annual average throughput of the No.2 PM will be increased by approximately 90 ADTPD to a total capacity of 524 ADPTD.

The following pollutants would increase from the new and modified units as a result of this project:

- 0.33 tons per year (tpy) particulate matter less than 10 microns.
- 0.16 tpy particulate matter less than 2.5 microns.
- 8.9 tpy volatile organic compounds.
- 3.5 tpy of toxic air pollutants.

Please review the project application and SEPA checklist for more information. As long as all applicable requirements are met, these increases are allowed under air quality standards.



#### **Commenting**

If we determine there is significant public interest during this comment period to hold a hearing, we will extend the comment period to allow at least 30 days notice and publish the time, date and location of the hearing.

## **Facility description**

This facility is a kraft pulp and paper mill and corrugated container plant. With around 400 employees, the pulp and paper mill makes about 1,800 tons of unbleached paper and corrugated medium each day. The container plant has about 155 employees and makes approximately 5 million square feet of corrugated boxes each day.
