Proposed permit renewal

We propose to renew the permit to continue to allow land treatment of commingled wastewater on nearby fields used for growing crops. Currently, Northwest Alloys, Inc. sells the harvested crops to the Washington State Department of Fish and Wildlife as winterfeed for elk. The commingled wastewater mainly consists of stormwater collected throughout the site.



The proposed permit allows Northwest Alloys, Inc. to land apply on 115 acres to grow alfalfa as long as certain requirements are met. The proposed permit also requires Northwest Alloys, Inc. to conduct a hydrogeologic study to better understand and characterize groundwater near the site. The proposed permit includes newly established performance-based interim limits for the commingled wastewater for total dissolved solids, nitrate, chloride, and sulfate.

Commenting and public hearing information

Effective comments tell us if we correctly applied current laws, rules, and regulations to this action. They:

- Are specific. Tell us what your concern is and how you think the permit should change.
- Are focused. Refer to the changes to the conditions and requirements in the permit.
- Describe the state rules and regulations you think have not been applied correctly.

If we determine there is significant public interest during this comment period to hold a hearing, it will take place **October 21, 2021**, starting at 6:00pm, online at
