Rule adoption and effective dates

Ecology expects to adopt this rule on June 22, 2021. The rule is effective on July 23, 2021

Appeal Procedures

This adoption can be appealed under procedures described in the Administrative Procedure Act (RCW 34.05), including those found in RCW 34.05.330.

Adopted Water Quality Permit Fee Rule

Ecology adopted amendments to chapter 173-224 WAC – Water Quality Permit Fees https://ecology.wa.gov/WOFeeRule.

The purpose of this chapter is to establish a permit fee system for state waste discharge and National Pollutant Discharge Elimination System (NPDES) permits issued by Ecology pursuant to RCW 90.48.160, 90.48.162, or 90.48.260.

The Washington Department of Ecology has adopted amendments to Chapter 173-224 WAC, Water Quality Permit Fees that requires Ecology to establish, by rule, annual fees to recover the cost of administering the wastewater and stormwater permit

We adopted rule amendments that include: 1) rollover of Fiscal Year 2021 fee amounts for Fiscal Years 2022 and 2023, 2) a new fee category for the Puget Sound Nutrient General Permit, 3) creation of subcategories for the Vessel Deconstruction fee category, and 4) technical changes. The final rule language clarifies in WAC 173-224-040 (3) (h) Ecology's legal limitation on assessing a fee against municipal wastewater facilities in excess of the statutory cap in RCW 90.48.465 (2). This rule amendment affects all water quality permittees.
