Cleanup process moving forward

The Department of Ecology (Ecology) is overseeing a cleanup of the Boathouse Inc Renton Skyway Site in the Skyway neighborhood, being done by GardnerGlobal, Inc (GG). Ecology is providing funding for this cleanup through their new Affordable Housing Cleanup Grant Program. This program ensures sites are "cleaned up properly while promoting community engagement and ensuring affordable housing in the process."

We would like your comments on the following documents:

- **Prospective Purchaser Consent Decree (PPCD)**: legal agreement that directs the purchaser to implement cleanup at the site, and provides the purchaser a settlement of liability.
- **Public Participation Plan**: document explains how people can participate in the cleanup process.

Background

The Boathouse Inc. Renton Skyway site (site) is a former retail store and dry cleaning facility located in Skyway, a neighborhood in unincorporated King County, Washington. The property is approximately 0.48 acres and zoned for community business use.

A dry cleaning facility, Ken's Skyway Cleaners, operated at the site from 1982 until 2002. Hazardous chemicals used in the dry cleaning business contaminated soil and groundwater.

GG is in a purchase and sale agreement to redevelop this Site as the Skyway Towncenter project (Project) This mixed-use, multi-family housing project will have the following:

- Approximately 250 total units
- At least 50 affordable rental units (20% of the total units)
- 30,000 square feet of commercial, office, and community space

The affordable units will be available for rent at 60%-80% of the area median income (AMI). The AMI is calculated annually by the Department of Housing and Urban Development for each county. Design elements for this space will be selected using community input and work from local artists. Contamination

Solvent-impacted groundwater has been confirmed on the property and the adjacent parcel to make up the site. The extent of the contamination will be determined in the remedial investigation. Municipal groundwater wells for the Skyway Water District (approximately 9,890 users) and the City of Renton (approximately 62,100 users) are located within 2 miles of the Site.

Investigations found the following contaminants in soil and groundwater:

- Tetrachloroethene (PCE)
- trichloroethene (TCE)
- cis-1,2-dichloroethene (DCE)
- vinyl chloride (VC)

All of these contaminants were found at levels above the state's cleanup law, the Model Toxics Control Act (\underline{MTCA}^{1}). MTCA requires these contaminants to be cleaned up.

Why this site matters

This site cleanup is made possible in part by funding from Ecology's <u>Affordable Housing Cleanup Grants</u>².

Washington is in dire need of affordable housing across the state. Contamination, or even the suspicion of contamination, drives up the costs of housing development. The high cost leaves little incentive for developers to build affordable housing.


In addition to the usual risks of redevelopment, cleaning up contaminated sites can be a complex process with considerable risk. The cost and time associated with cleaning up a site is often poorly understood; as a result, many sites are left vacant or underused for years, even decades. Supporting cleanups for affordable housing helps make sure the cleanup gets done, protecting the community's health and the environment.

Ecology developed the Affordable Housing Cleanup Grant Program (AHCGP) to help advance environmental cleanups for affordable housing developments. These grants can cover remedial action costs, including planning, investigative, and technical work needed to clean up contaminated sites. The purpose of the AHCGP is to expedite the cleanup and redevelopment of contaminated sites into affordable housing use and lessen the impact of cleanup costs.

What happens next?

Ecology will consider all comments received and may amend the documents based on your comments. After that, the PPCD and Public Participation Plan will be finalized, and the formal cleanup will begin. A Remedial Investigation and Feasibility Study will then be completed. Results from the Remedial Investigation and Feasibility Study will lead to a Cleanup Action Plan. Drafts of the Remedial Investigation and Feasibility Study as well as the Cleanup Action Plan will be available for public review and comment. (See graphic below.)
