Site background and land use

Georgetown is a neighborhood just south of downtown Seattle. It has many residences and small businesses, despite being surrounded by industry and major transportation corridors. This industrial neighborhood boasts fun places to eat, art galleries, and urban breweries.

Notable Georgetown landmarks include the Burlington Northern Santa Fe (BNSF) Railway and Union Pacific Railroad to the north, the Duwamish River to the west, Interstate 5 (I-5) to the east, and Boeing Field to the south. Nearby neighborhoods include South Park to the west and Beacon Hill to the east.

This environmental cleanup is for co-mingled groundwater contamination from four businesses. These businesses are:

- Art Brass Plating, Inc.: 5516 3rd Ave. S., Seattle, Washington, 98108.
- Blaser Die Casting, Co.: 5700 3rd Ave. S., Seattle, Washington, 98108.
- Capital Industries, Inc.: 5800 3rd Ave. S., Seattle, Washington, 98108.
- Clean Earth/ Burlington: 734 South Lucile Street, Seattle, Washington, 98108.

"West of 4th" is the cleanup site created by the co-mingled contamination from these four businesses.

In 2014, we issued an agreed order that requires all four of these businesses (the potentially liable parties) to cleanup the contaminated groundwater.

The West of 4th site is in the Georgetown neighborhood, between 4th Avenue South and the Lower Duwamish Waterway. For the feasibility study (FS), the site was divided into two site units:

- Site Unit 1 (SU1): Art Brass Plating and Burlington Environmental.
- Site Unit 2 (SU2): Blaser Die Casting, Capital Industries, and Burlington Environmental.

The West of 4th FS reports for SU1 and SU2 were submitted in 2016 and were approved by Ecology. Interim actions were implemented, including two pilot studies in SU1 to evaluate whether remedial technologies identified in the FS were effective at this site. After the pilot studies, the potential remedies were re-evaluated in two focused FS addenda – one for SU1 and one for SU2.

This comment period is for the FS and the two focused FS addenda.

Following Ecology's review of the FS and FS addenda, we will select our preferred cleanup action for the site. The cleanup actions will be described in a draft cleanup action plan (CAP) and made available for public review. At that time, we will also draft a new agreed order (AO). After public comment on the CAP and new AO, Ecology will finalize the documents and the four companies will design and implement the selected cleanup actions.

Contamination

Groundwater contamination from four neighboring business has co-mingled. According to the remedial investigation, groundwater contamination includes:

- Chlorinated solvents (PCE, TCE, DCE, and VC)—chemicals that may cause cancer.
- Metals (arsenic, copper, manganese, nickel, and zinc)—chemicals toxic to surface water organisms.

Cleanup process

The four businesses that are potentially liable parties will finalize the feasibility studies for the site and develop a draft cleanup action plan to clean up the groundwater under the existing agreed order.

Ecology uses the RI and FS to select cleanup actions for the site. We oversee site cleanup activities, which must meet all federal and state standards.

The four potentially liable parties must clean up the contamination at the site. There are six phases in the cleanup process: remedial investigation, feasibility study, cleanup plan, cleanup design, cleanup implementation, and monitoring and site use controls.

Interim actions or partial cleanups can occur at any time. There will be opportunities for public comment at each stage, except for cleanup implementation.

We apply both the Resource Conservation and Recovery Act (RCRA) and the Model Toxics Control Act (MTCA) regulations to clean up hazardous waste sites. The cleanup protects human health and the environment from dangerous wastes and chemicals.
