Column Name	Description and Notes
Ecology Issuance ID	The unique identification number for each Issuance. If the final letter is followed by a number, the number represents a second (or third or fourth) issuance for that reporting period.
OPR Project ID	The unique identification number for each offset project assigned by the Offset Project Registry that listed the project.
Project Type	Identifies one of the four offset project types approved by the Board: 1) U.S. Forest Projects (Forest) 2) Ozone Depleting Substance Projects (ODS) 3) Livestock Projects (Livestock) 4) Urban Forest Projects (Urban)
Reporting Period Start Date	The start date of a reporting period.
Reporting Period End Date	The end date of a reporting period.
Vintage	The vintage of the Ecology offset credits issued. The vintage is the year in which the reporting period ended. For Ecology offset credits (unlike allowances), vintage is descriptive to help identify the reporting period and does not affect whether it may be used to meet a compliance obligation.
Ecology Offset Credits Issued	The number of Ecology offset credits in this issuance, including any credits for the Forest Buffer Account.
Forest Buffer Account Contribution	The number of Ecology offset credits placed in the Forest buffer account for each Forest project (see WAC 173-446-570).
Issuance Date	Date Ecology offset credits were issued. The user may search this column to identify the most recent Ecology offset credits issued.
Invalidation Time Frame	The number of years, either 8 years or 3 years, during which the issued Ecology offset credits may be invalidated (see WAC 173-446-580).
Date Invalidation Period Reduced	The date the invalidation period was reduced from 8 years to 3 years. The user may search this column to identify the invalidation periods most recently reduced.
Start of Invalidation Timeframe	The date the invalidation timeframe of either 8 years or 3 years began. It is the end date of the reporting period.
Offset Project Name	The name of the offset project as selected by the Offset Project Operator.
Offset Project Operator	The entity with legal authority to implement the offset project.
Verification Body	The Ecology-accredited offset verification body which provided offset verification services for the reporting period.
State	State in which the offset project occurred. For Forest projects in multiple states, this is the state in which the majority of the project area is located. For ODS projects, this is the state in which destruction occurred.
Provides DEBS	Projects that qualify as providing Direct Environmental Benefits in the State (DEBS) pursuant to WAC 173-446-595 are denoted as "DEBS" in this column. Projects for which Ecology has not evaluated whether the project provides DEBS or has determined the project does not provide DEBS are denoted with a dash ("-") in this column.
DEBS Documentation, if applicable	Projects that qualify for DEBS pursuant to section WAC 173-446-595(2) must submit an application for DEBS determination. For those projects that have submitted applications and been determined to provide DEBS, this column includes a link to the project application and Ecology determination. Projects which automatically qualify pursuant to WAC 173-446-595(1), projects for which Ecology has not evaluated whether the project provides DEBS, and projects Ecology has determined do not provide DEBS are denoted with a dash ("-") in this column.
Project Documentation	Link to the offset project data on the Offer Project Registry's website. Documentation includes the Listing, Offset Project Data Report, and Offset Verification Statement.
Buffer Pool Retired	The number of Ecology offset credits from the Forest buffer pool which have been retired to compensate for unintentional reversals.
Retired for Intentional Reversal	The number of Ecology offset credits which have been retired to satisfy an obligation from an intentional reversal.
Retired Voluntarily	The number of Ecology offset credits which have been voluntarily retired.
Comment	Additional information, when applicable, about invalidations, intentional reversals, unintentional reversals, voluntary retirements, and other aspects of the project.
