Issued on December 20, 2023.

This report lists Washington cap-and-invest entities with active accounts in the Compliance Instrument Tracking System Service (CITSS) as of 5:00 PM on Thursday, November 30, 2023. This report may not reflect in-progress account changes, such as facility retirement and ownership changes.

The "CITSS ID" is the unique identifier assigned to the entity's Washington cap and invest entity in CITSS. The "Entity Legal Name" is the name entered into CITSS by the entity's account representatives. The "CITSS Entity Type" is the account type in CITSS that corresponds to the entity's compliance status. CITSS has three entity type options:

- 1. Covered Entity, Covered Source, or Opt-in Entity¹,
- 2. General Market Participant Organization², and
- 3. General Market Participant Individual.

² <u>WAC 173-446-055</u>: General market participants are entities that are either below the 25,000 MTCO2-e threshold and are not interested in opting in or are not responsible for emissions, but would still like to participate in the cap-and-invest market through allowance trading.
