Washington Cap-and-Invest Program APCR Auction #3 October 2024 Public Proceeds Report

Issued on October 30, 2024

Background

Ecology held an auction of allowances on October 2, 2024 (APCR Auction #3). This auction included the sale of allowances from the Allowance Price Containment Reserve (APCR). Ecology approved the results of the auction and issued an <u>Auction Summary Report</u> on October 9, 2024.

This Public Proceeds Report provides information regarding proceeds to the State of Washington from the sale of allowances at APCR Auction #3. Only state-owned allowances are offered at APCR auctions, and therefore no allowances were consigned for sale.
