Air Quality Local Partner Woodstove Education & Enforcement 2025-27 Application Instructions

Purpose: The purpose of these instructions is to ensure that our local air agency partners are able to review, edit, and submit their 2025-27 Woodstove Education & Enforcement application.

Access to Ecology's Administration of Grants and Loans (EAGL) Database

Wood Stove Education & Enforcement 2025-27 applications are to be completed and submitted via Ecology's EAGL (Ecology Administration of Grants and Loans). To access the system, applicants must first:

- Register for a Secure Access Washington (SAW) online services account.
 To register for a SAW account, visit Secure Access Washington in order to access the EAGL system. SAW accounts may take some time to set up, so starting early is encouraged. Each staff member of an organization that will have a role in the project (e.g., project manager, financial manager, and grant signatory) must each establish their own separate SAW account before you can apply. You may not share a SAW account with another person or organization.
- 2. Register as an EAGL User.
 After registration for SAW is complete, you will then apply for EAGL Services. Confirmation of your organization role, and approval for EAGL is done manually, and may take 3-5 business days.

a. Change or Accept the Information:

Fourth. Select Save. You MUST select SAVE again or the map will remain checked out to you.

- b. Select SAVE.
- c. Use the navigation links at the bottom of your screen to advance to next form OR use your cookie crumbs to go back to the forms menu

- a. Task cost must equal your award amount since both education and enforcement have been incorporated into a single task.
- b. Due date for each deliverable is 6/30/27. You can leave the other boxes blank.
- c. There are no additional tasks or deliverables connected with this funding source
- d. Select SAVE.

- f. Task cost is \$0. This task is strictly being used to highlight a few very important recipient responsibilities.
- g. Due date for each deliverable is left blank, as the "final" PRPR and the Recipient Close Out report are not due until July 30, 2027. This date would be after the expiration date and would cause EAGL issues. The due date is mentioned within the deliverable description.
- h. Select SAVE.
- i. Use the navigation links at the bottom of your screen to advance to next form OR use your cookie crumbs to go back to the forms menu

√ Scope of Work – Summary

FYI: There is only one task in the Woodstove Education & Enforcement grant

- a. Task cost must equal your award amount since both education and enforcement have been incorporated into a single task.
- b. Due date for each deliverable is 6/30/27. You can leave the other boxes blank.
- c. Select SAVE.
- 4. Select CHECK GLOBAL ERRORS at the top of your screen. Correct any errors that may occur. This may not mean corrects. It may result in simply selecting SAVE again on the form. Continue selecting CHECK GLOBAL ERRORS, until no errors are found. When no errors are found, proceed with #5.
- 5. Select your "Application Name" at the top of the screen, next to Document Information.


