This report lists Washington cap-and-invest entities with active accounts in the Compliance Instrument Tracking System Service (CITSS) as of 4:00 PM on February 28, 2025. This report may not reflect in-progress account changes, such as facility retirement and ownership changes.

The "CITSS ID" is the unique identifier assigned to the entity's Washington cap and invest entity in CITSS. The "Entity Legal Name" is the name entered into CITSS by the entity's account representatives. The "CITSS Entity Type" is the account type in CITSS that corresponds to the entity's compliance status. CITSS has four entity type options:

- 1. Covered Entity, Covered Source, or Opt-in Entity,¹
- 2. General Market Participant– Organization,²
- 3. General Market Participant Individual, and
- 4. General Market Participant Offset Only.³

² <u>WAC 173-446-055</u>: General market participants are entities that are either below the 25,000 MTCO2-e threshold and are not interested in opting in or are not responsible for emissions but would still like to participate in the capand-invest market through allowance trading.

³ Certain general market participants which register with Ecology pursuant to <u>WAC 173-446-520</u> may *only hold offset credits* without completed disclosures identified in <u>WAC 173-446-120</u>. Entities of this type may not hold or transfer allowances until updated disclosures identified in <u>WAC 173-446-120</u> are sent to Ecology.
