**Washington Cap-and-Invest Program
2025 Quarter 2 CITSS Holdings Report**

Issued on June 18, 2025

The Department of Ecology is required to summarize the number of compliance instruments (greenhouse gas allowances and offset credits) held in each Washington cap-and-invest entity's general holding account in the Compliance Instrument Tracking System Service (CITSS)¹. This report also includes instruments held in an Electricity Allocation Holding Account (EAHA)². The following list includes the holdings report as of 4:00 PM on May 30, 2025.

The totals below do not include compliance instruments held in an entity's Limited Use Holding Account (LUHA) that are used for consignment, or instruments held in a compliance account to meet a compliance obligation. Account numbers listed in this report are randomly assigned and do not correspond to entity account numbers in CITSS.

The total number of accounts may differ between reports as transfers are conducted into and out of the applicable accounts by the deadline the data for the report is pulled. This report does not include accounts with a zero balance.
