Air Quality Registration Program

Ecology has operated an Air Quality Registration Program since the early 1970s. About 500 air pollution sources are registered with Ecology by businesses throughout central and eastern Washington and San Juan County. Ecology uses the Registration Program to develop and maintain a current and accurate record of industrial and commercial sources of air pollution. The information we collect through this program helps us evaluate the effectiveness of air pollution control strategies and verify whether a facility is meeting air pollution requirements.

Q: How does the registration process work?

A: The program has three parts: emissions inventory, emission calculations, and inspections.

Emissions inventory

Ecology collects information from registered businesses. This information is due back to Ecology by January 31. The information collected will provide details about the businesses' processes, sources of air emissions, emission control devices and material throughput.

Emission calculations

Businesses provide information on their air emissions. Ecology uses this information to determine which air pollution rules apply and the registration category for that business.

Inspections

Ecology periodically inspects the registered business to verify information submitted, answer questions, and determine compliance with air quality rules and permits. After an inspection, Ecology notifies the business of the results of the inspection.

Q: What are the Registration Program categories?

A: The amount of air pollutants emitted by a source determines its registration program category. There are three registration categories:

- Annual Emission inventories and inspections are required every
- Periodic Emission inventories and inspections are required every
- Exempt Emission inventories are required every six years, with no regular inspections

Businesses that move between categories may be required to turn in an emission inventory more frequently to ensure they are in the correct category. You can find more information about the Registration Program Emission Rates Table on our web site:

Q: Which sources must register?

A: WAC 173-400-100 identifies types of sources that must register with Ecology. They are identified by: category, equipment type, federal rule, and emissions limits in the permit. Q: How does a business register with Ecology?

A: Existing businesses with sources of air pollution will be asked to fill out registration forms provided by Ecology. These forms include process information, sources of air emissions, emission control devices, and material throughput. Businesses establishing new air pollution sources must first apply for an air quality permit (Notice of Construction) with Ecology. This permit process will request most of the information needed to initially register your business. Q: Does a business have to register if it doesn't need a permit?

A: Some businesses may have to register and pay fees even if they not required to obtain an air quality permit.

Q: Are there fees associated with registration?

A: Yes. Fees are charged annually based on emissions or source category. Some businesses may qualify for a fee reduction or payment plan. You can find more information about these options on our web site: http://www.ecy.wa.gov/programs/air/permit register/Registration.html#fee.

Q: When should I notify Ecology about changes to my business?

A: All businesses must notify Ecology prior to change of ownership, closure, expansion, adding new equipment, or changing out/replacing existing equipment. Call your regional office representative if you have questions. Find your regional contact on Page 1.

Q: How do I avoid common problems found during inspections?

A: The best ways to avoid common problems are:

- Know what permits you have, where they are located, and what they require
- Make sure workers follow practices and keep documentation required by permits and state rules
- Properly operate and maintain your equipment
- Keep track of material use
- Minimize creation of dust from such things as paved and unpaved roads, materials handling and storage, and equipment
- Keep containers of volatile materials covered when not in use
