In the matter of adopting, on November 29, 2022, the Intalco Sulfur Dioxide Attainment Plan and Agreed Order #21310 as a revision to the State Implementation Plan

Adoption Order

The Washington State Department of Ecology and the Northwest Clean Air Agency developed the Intalco Sulfur Dioxide Attainment Plan (Plan) to permanently reduce the amount of sulfur dioxide (SO₂) pollution in the Intalco Sulfur Dioxide Nonattainment Area. In support of the Plan, Ecology finalized Agreed Order # 21310 on November 29, 2022. It requires the Intalco smelter to install and operate a new SO₂ wet scrubber, merge existing stacks and increase the height of the merged stacks, and limit facility-wide and unit-specific SO₂ emissions in association with restart of facility operations.

The Intalco SO₂ Nonattainment Area is located in Whatcom County and encompasses the site of an aluminum smelter, Intalco Aluminum LLC (Intalco), and adjacent areas. The U.S. Environmental Protection Agency (EPA) designated it as a nonattainment area in December 2020, after the air quality monitoring results showed it failed to meet the 2010 1-hour SO₂ National Ambient Air Quality Standard. The area designation became effective April 30, 2021, requiring the state to submit a plan to EPA by October 30, 2022.

This Plan is a federally required revision to the Washington State Implementation Plan (SIP) and provides for attainment of the 2010 SO_2 standard in the area by April 30, 2026. Ecology complied with public notification requirements for SIP revisions and solicited public review from September 7 through October 15, 2022. We held a hearing on October 11, 2022.

IT IS HEREBY ORDERED that the referenced documents, constituting the revision, are approved and adopted by the Director of the Department of Ecology, on behalf of Governor Inslee, as part of the Washington SIP. All provisions of the Washington SIP inconsistent with the attached documents are superseded.
